CALL TO ORDER

Called to order by Mayor Gib Coerper.

AGENDA ITEM

A. Utility Rates

Finance Director Marcian Brown introduced the item and Public Services Director Marcus Collins presented the staff report.

The commissioners engaged in discussion regarding utility rates and the process for rate changes. They asked that the presentation for public explanation should be illustrated in such a way that makes it very clear about how much of an estimated increase a customer will see on his or her monthly bills, including electricity in the total.

City Manager Traci Cain advised that the mandatory public notices, advising that a rate increase is being considered and including the dates and times for the rate increase hearings, have already been sent out. She said the materials for the public meetings will have the information as the commissioners have directed to clearly reflect the estimated increases customers may expect.

The commissioners engaged in discussion about the Florida Public Service Commission price index.

Assistant City Manager Adam Boukari reminded the commissioners that automatic adjustment according to the FPSC price index is in the ordinance, but it is reviewed annually because Florida statutes do not allow for rate increases without the hearings. He said that it could be made clear in the public presentations that the adjustments do not occur without the review process.

Public Services Director Collins was directed to find out for the Commission how many of the City utility customers use all of the utility services/types provided by the City.

B. General Budget Discussion

Finance Director Marcian Brown provided an overview of the remaining Budget Schedule including the hearings for rate increases. He said the TRIM notices will go out in mid-August and commissioners will vote on the rate increase in September. after hearings on the millage rate.
