

and loosened restrictions on beer-growler sales, said he expected to lose Gainesville, the University of Florida and most, if not all, of Alachua County.

"I served on the redistricting committee and we reviewed all nine maps submitted by the League of Women Voters and the plaintiffs and did so because they declined an invitation to appear before the committee," Bradley said Wednesday.


"Five of the nine maps split Alachua County so I'm genuinely perplexed by the argument coming up now that it is somehow problematic to have a map that splits Alachua County and still comply with the Constitution," he said.

On the eve of Wednesday's Senate vote, the plaintiffs submitted a map that would place all of Alachua County in a new District 7 with Gilchrist, Levy and western Marion County.

Under that scenario, Clay County was in an upside-down horse-shoe-shaped district that also included Putnam, Bradford, Union, Baker, Columbia, Suwannee, Dixie and Lafayette counties.

Alachua County and Gainesville would be split between two state senate districts under the senate's proposed map, which state senators approved 22-18 Wednesday. Marion County would remain intact under the plan, which still faces scrutiny from the state House of Representatives.

by Senate staff would have kept Alachua County whole and could have pitted Bradley and St. Johns County Republican Travis Hutson against one another.

The battle over the Florida Senate presidency added some political intrigue to Latvala's criticism of splitting Alachua County, because Bradley and Hutson both support Stuart Republican Joe Negron as the next Senate president.

The maps the Senate approved Wednesday — with every Democrat and a handful of Republicans in opposition — divide Alachua County and Gainesville between newly drawn districts 4 and 5.

Gainesville is the only divided city and Alachua

County is the only divided county in the two districts.

District 4 includes Clay, Baker, Bradford, Union, Columbia, Suwannee and Lafayette counties and the eastern, northern and northwestern areas of Alachua County. That district would have 87,632 total county residents, including 41,880 in Gainesville.

The new district 5 would include western Alachua County, with the exception of the northwest area, with 159,704 Alachua County residents, including 82,474 in Gainesville. The district would stretch west to include Dixie, Gilchrist and Levy counties, then wind south, picking up Citrus and Sumter.

That district's 133-mile length from its northern

boundary to its southern tip makes it the third longest of the 40 senate districts and more than twice the 62.3-mile average.

Speaking about the contours of that district, Bradley said he felt senators had to try and strike a balance between compact and contiguous districts and trying to follow the political boundaries of counties.

He said the maps the

Senate advanced Wednesday split counties less often than other options and followed natural boundaries, such as rivers, as much as possible.

While the redistricting process divided Alachua County, it unified Marion County into one district. Previously divided between Florida Senate districts 5, 8, and 11, Marion County would now stay whole in a district that includes Putnam and northern Lake.

The maps go to the Florida House next week. State Senate President Andy Gardiner R-Orlando said the two houses may then have to try and reach

a compromise.

With the World Series underway, Gardiner said "we're in the first inning."

Earlier in the week, State Rep. Keith Perry, R-Gainesville, said he felt Alachua County could benefit from being split into two districts. He said that would give the county two representatives in Tallahassee pushing for funding and other issues.

Perry said he's been contacted about his interest in running for one of the two Alachua County senate districts, should the county remain split in the final map. But he said he hasn't decided.

heart doesn't receive the amount of proper circulation and his condition keeps him from lung or heart transplant eligibility.

"When his left lung fails, it'll fail," Booth said. "And then probably his heart will go soon after that."

Though his bouncing personality doesn't show it, Austin's also too weak for another open heart surgery; he has already had two. Instead the doctors and family have resorted to placing stents and coils to keep his arteries open.

"Basically whenever his time is through, he'll go to heaven," his mother said. After watching Austin's health continue to decline and Booth struggle to make the most of their remaining time, Booth's best friend, Michelle Lee, created a fundraising campaign on GoFundMe.com entitled "Austin's Dream Hunt 2015" to cover the cost Austin's passion: hunting. As of Wednesday, they have raised \$125 toward their goal of \$1,500.

Lee said because of his illness, he can't run and play like most children because he'll get out of breath quickly, so hunting has become one of the few recreational outlets that Austin can enjoy. Lee said she's watched Booth struggle to provide the money to drive and fly Austin to hunting locations.

"She doesn't have anybody to help her, but she'll do it anyway," Lee said.

The campaign was made in hopes of granting Austin's wish to hunt a whitetail or red deer, animals that, at the mention, cause his camouflage hat-covered head to perk up and arms to lift to demonstrate how large deer are. "They're huge," he said with widened eyes.

The family hopes to raise the money to cover the cost of traveling to its three hunting grounds in Missouri, South Carolina and Alabama over the next year.

Upon arrival, the hunting company Buckmasters will cover the cost of shelter, food and training, which it does for disabled veterans and families with children who have life-threatening diseases.

For Austin, the list of illnesses he faces is

extensive.

He was diagnosed at birth with complex congenital heart disease, heterotaxi (two right lungs), a heart with only one ventricle (instead of two), cyanosis (lack of oxygen which turns his skin blue) and aspenia (abnormal spleen).

In his short life, he's already undergone a slew of surgeries including two open-heart surgeries, nine heart catheterizations and nine stents and coils and a surgery that untwisted his bowels from his heart.

According to Booth, doctors discovered a hole in her son's heart during the 27th week of pregnancy, but doctors still don't know what caused it or how the other abnormalities sprouted.

Booth also has a 14-year-old daughter, Savannah, who was born healthy.

As if his health concerns weren't enough, his wheelchair and blue skin have subjected him to bullying at school.

Last year, his mother had to request that the bathroom be cleared when Austin uses it. According to Booth, boys picked up her son and threw him against a wall.

Austin said he feels scared whenever other students bully him.

Booth said she struggles as a widowed, single mother to provide a good life for both children, despite working as a nurse in the cardiology department at Spring Hill for UF Health. She said she's often caught between paying the cable bills and taking money out to go on hunting trips with her ailing son.

Austin surpassed doctors' expectations Tuesday by celebrating his ninth birthday with his supportive family. They celebrated his birthday with a trip to Legoland.

"I always try to make sure he's happy. I try to make sure he fulfills everything he wants to fulfill — that he never goes without," Booth said. "Because I never want to regret something

that I could've done or wish I would've done."






