and was acting disorderly in the streets of High Springs. Instead of arresting him again, Bryant sent Jordan home in a buggy with a driver.

When the driver did not return, Bryant and the owner of the buggy went to Jordan's residence. Once at the residence, the driver allegedly ran out of the house claiming Jordan had held and beaten him and threatened to kill him.

Bryant approached the front door and began talking with Jordan. Bryant began to enter the door, at which point witnesses stated they heard a gunshot. Several shots were exchanged, resulting in two wounds to Bryant, one of which was just above his heart and reportedly resulted in an almost instant death.

Jordan later claimed self-

defense, testifying that Bryant had previously threatened him, broke open his door and fired his gun at Jordan first. The jury disagreed, however, and convicted Jordan of second degree murder.

Bryant's name was previously added to the National Law Enforcement Officers Memorial in Washington, D.C. in 1996 after his great grandson, Sgt. David Rivers of the Metro-Dade Police Department, discovered that Bryant's name had not been included.

Bryant is buried at the Spring Hill Church Cemetery in Traxler. He remains the only law enforcement officer killed in the line of duty in High Springs.

Christmas trees: Christmas tree fires are not common, but when they do occur, they're much more likely to be deadly than most other fires. One of every 31 reported home Christmas tree fires results in a death each year, compared to an annual average of one death per 144 total reported home fires.

Candles: December is the peak time of year for home candle fires; the top four days for home candle fires are New Year's Day, Christmas, New Year's Eve and Christmas Eve. In December, 11 percent of home candle fires began with decorations, compared to 4 percent the rest of the year.

Notice is hereby given that the City Commission of the City of Alachua will hold a public hearing on a proposed ordinance. The hearing will be held on Monday, December 14, 2015 at 6:30 p.m., in the James A. Lewis Commission Chambers in City Hall, located at 15100 NW 142nd Terrace, Alachua, Florida.

The ordinance title is as follows:

ORDINANCE 16-02

AN ORDINANCE OF THE CITY OF ALACHUA, FLORIDA, PROVIDING AN EXTENSION OF ORDINANCE 15-08, EXTENDING FOR THREE (3) MONTHS THE TEMPORARY MORATORIUM ON ALL APPLICATIONS FOR DEVELOPMENT APPROVAL FOR "DISPENSING ORGANIZATIONS" AS DEFINED BY CHAPTER 2014-157, LAWS OF FLORIDA, AND AS FURTHER DEFINED IN CHAPTER 64-4.001, FLORIDA ADMINISTRATIVE CODE, AND PROVIDING FOR A THREE (3) MONTH MORATORIUM ON ALL APPLICATIONS FOR DEVELOPMENT APPROVAL FOR "DISPENSING ORGANIZATION FACILITIES" AS DEFINED IN CHAPTER 64-4.001, FLORIDA ADMINISTRATIVE CODE; PROVIDING FOR EXEMPTIONS; PROVIDING FOR AN ADMINISTRATIVE REMEDY; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

At the public hearing, all interested parties may appear and be heard with respect to the proposed ordinance. Copies of the proposed ordinance and related materials are available for public inspection at the Planning and Community Development Department, 15100 NW 142nd Terrace, on any regular business day between the hours of 7:30 a.m. to 6:00 p.m. Written comments on the proposed ordinance may be sent to the following address: City of Alachua, Planning and Community Development, P.O. Box 9, Alachua, FL 32616. Notice is given pursuant to Section 286.0105, Florida Statutes, that, in order to appeal any decision made at the public hearing, you will need a record of the proceedings, and that, for such purpose, you may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based. In accordance with the Americans with Disabilities Act, any persons with a disability requiring reasonable accommodation in order to participate in this meeting should call the City Clerk at (386) 418-6100 x 101 at least 48 hours prior to the public hearing.
