

- 1. DRA 4 Within the project GMP eliminate the complete removal and repair of the VVRS systems. In lieu of complete repair the contractor shall investigate the depressional areas at the surface of the 2 VVRS and repair them and then restore the ground level and sod.
- 2. DRA9 The contractor shall save the existing fence, and remove and replace a small section for site access. The GMP shall include minor fence work noted above and the spillway and minor grading to be able to build the spillway. The remaining work scope of over-excavation and backfill, and finally re-grading the basin shall be listed as alternatives to the contract and if there is any project savings the owner may consider these further remediation efforts.
