


## NOTICE OF PUBLIC HEARING BEFORE THE PLANNING AND ZONING BOARD OF THE CITY OF ALACHUA, FLORIDA

Notice is hereby given that the Planning & Zoning Board of the City of Alachua will hold a public hearing(s) on April 19<sup>th</sup>, 2016 at 6:30 p.m. The hearing(s) will be held in the James A. Lewis Commission Chambers in City Hall, located at 15100 NW 142<sup>nd</sup> Terrace, Alachua, Florida, to consider the following: A request by Ryan Thompson, AICP, of Causseaux, Hewett, & Walpole, Inc., applicant and agent, for Upland Properties of NCF, LLC, property owners, for consideration of a Small Scale Comprehensive Plan Amendment (SSCPA) to the City of Alachua Future Land Use Map from Industrial to Commercial. The ±2.5 acre property subject to the proposed amendment is located south of NW US HWY 441, east of Southern Custom Truck and Auto Accessories, and west of Webster Veterinary Supply, consisting of Tax Parcel Nos. 05964-002-001, 05964-002-006, and portion of 05964-002-00.
