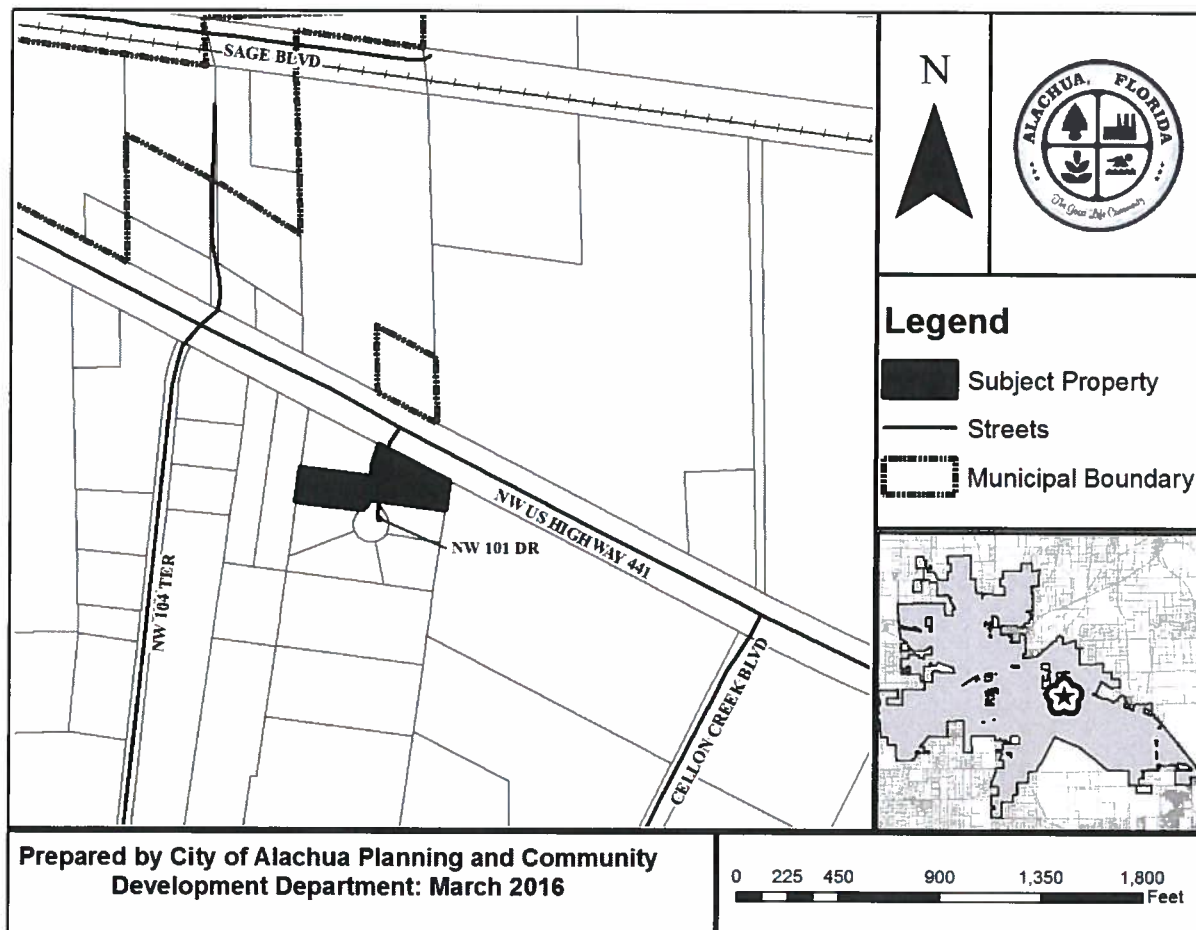
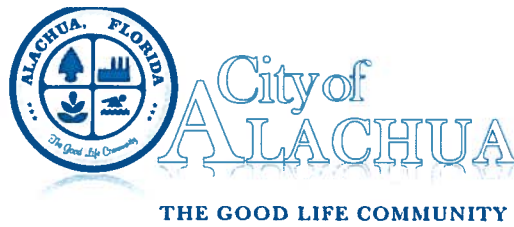

NOTICE OF PUBLIC HEARING BEFORE THE PLANNING AND ZONING BOARD OF THE CITY OF ALACHUA, FLORIDA

Notice is hereby given that the Planning & Zoning Board of the City of Alachua will hold a public hearing(s) on April 19th, 2016 at 6:30 p.m. The hearing(s) will be held in the James A. Lewis Commission Chambers in City Hall, located at 15100 NW 142nd Terrace, Alachua, Florida, to consider the following: A request by Ryan Thompson, AICP, of Causseaux, Hewett, & Walpole, Inc., applicant and agent, for Upland Properties of NCF, LLC, property owners, for consideration of a request to amend the City of Alachua Official Zoning Atlas (rezoning) from Light and Warehouse Industrial ("ILW") to Commercial Intensive ("CI"). The ± 2.5 acre property subject to the proposed amendment is located south of NW US HWY 441, east of Southern Custom Truck and Auto Accessories, and west of Webster Veterinary Supply, consisting of Tax Parcel Nos. 05964-002-001, 05964-002-006, and portion of 05964-002-00. Notice is given pursuant to Section 286.0105, Florida Statutes, that, in order to appeal any decision made at the public hearing, you will need a record of the proceedings, and that, for such purpose, you may need to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based.
