A. Resolution 16-12 Accepting the Comprehensive Annual Financial Report (CAFR) and Management Letter for the Fiscal Year ended September 30, 2015

City Attorney Marian Rush provided the reading of Resolution 16-12 by title only.

Finance and Administrative Services Director Robert Bonetti introduced the item and provided the staff report.

Ron Whitesides and Trey Presnell of Purvis Gray & Company were introduced by Finance and Administrative Services Director Bonetti.

Mr. Whitesides said the City had received an Unmodified Opinion which is the highest rating that can be received in the annual audit. He presented the Comprehensive Annual Financial Report (CAFR) for the Fiscal Year ended September 30, 2015.

The commissioners engaged in discussion regarding retirement funding and the effects legally and fiscally when a pension is not fully funded.
