Activist comes to Ocala

Pfaff travels the US through Heroin Is Killing My Town

When Billy Pfaff hits the road — and that’s often for Pfaff, who has cultivated a nationwide support network for heroin addicts — he brings with him a dire message: “This heroin epidemic is going to wipe out this beautiful community.”

On Wednesday, when he had gathered 15 or so people at the downtown square, he was referring to Ocala. Other days he takes that warning to communities in Connecticut, Maryland, Massachusetts, New Jersey or Rhode Island. His next stop is Pennsylvania, where he said he plans to meet a young woman who reached out to him for help.

As the force behind Heroin Is Killing My Town, a Massachusetts-based nonprofit he founded two years ago after losing his best friend to a heroin addiction, Pfaff is often on the road. He estimates his reach, through Facebook, already stretches to 1.7 million people. And that network swells greater through stops like the one this week in Ocala, where he asked the small crowd to further his mission in Central Florida.

“I need all the help I can get out here,” he told them.

The activist came to Ocala at the invitation of Jonathan Duffany, who knows firsthand the power of Pfaff’s network.

He drew on it the day after Christmas, he said, when he first reached out to Pfaff on Facebook.

“I didn’t want to live the way I was living,” Duffany said.

As someone who had never even smoked marijuana, Duffany said he never thought he would see himself addicted to heroin. He fell onto that path after a shoulder surgery left him dependent on pain medication. That he had lost a brother and a cousin in a car accident around the same time complicated his situation.

Duffany said he had been using heroin for about three months when he came to Florida to visit family for Christmas. He decided to stay rather than return to his habit in Massachusetts, where he had been running his own carpentry business. When he finally reached out to Pfaff on Facebook, he said, Pfaff was on the phone with him almost immediately.

Pfaff connected him with a local woman who helped him into an inpatient facility in Leesburg, where Duffany, who now

lives in Ocala, said he got clean over nearly four months.

On Wednesday, Pfaff called on the small crowd to act as his local network for people, like Duffany, who reached out to him from Central Florida. He also called on them to “wake up” the city, suggesting they connect with hospitals, law enforcement and school systems to address the problem

comprehensively.

Of particular concern to Pfaff is the rise of fentanyl, a synthetic drug he said is significantly more powerful — and more dangerous — than heroin. “You don’t go back to a lesser high,” he said. “It controls your life.”

Pfaff himself said he had never been a drug addict; what he knows about addiction and overcoming it comes from his years supporting others. He had been working as a tattoo artist in Boston before turning to Heroin Is Killing My Town full-time in 2014.

The gathering wrapped up in just under an hour on Wednesday afternoon. Especially considering it was organized with little notice, Pfaff said he was happy with the turnout.

“Even if I reach just two people,” he said, “I’ll be happy.”

Commission wants disaster declared over blue-green algae

STUART — County officials on Florida’s Atlantic coast want the U.S. Army Corps of Engineers to close the locks between Lake Okeechobee and the St. Lucie River.

The Palm Beach Post reports the Martin County Commission decided at an emergency meeting Tuesday to ask state and federal authorities to declare a disaster where blue-green algae has closed beaches.

“This is our Deepwater Horizon. It’s time the federal and state government understand how God-awful the problem is here,” Commissioner Doug Smith said.

To keep water levels in the lake between 12.5 feet and 15.5 feet above sea level and relieve pressure on its aging earthen dike, the corps releases water east and west of the lake into the Caloosahatchee and St. Lucie rivers.

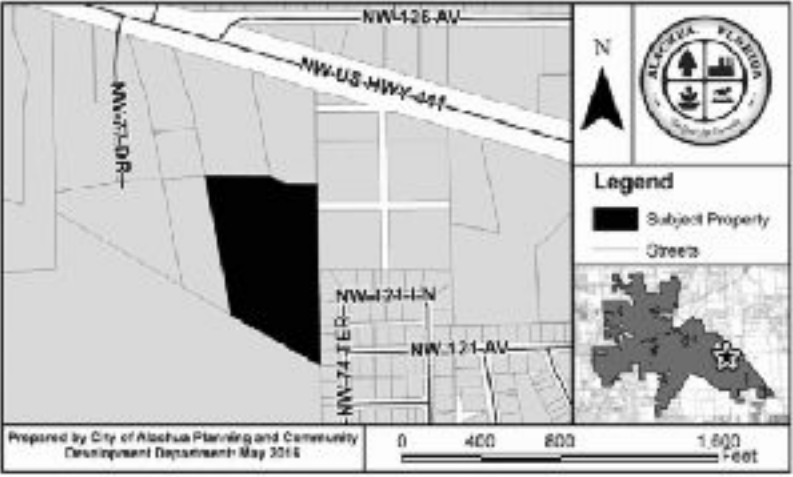
Coastal communities have said the discharges pollute local ecosystems, harming wildlife and the economy. Martin County commissioners heard complaints from local residents and business owners for three hours on Tuesday.

“We’ve had rashes on our hands. We’re losing thousands of dollars. I want this fixed,” Bruce Hrobak, owner of Billy Bones Bait & Tackle, one of about 250 people who crowded into the commission chambers.

The algae closed beaches this week along the Treasure Coast shoreline, the St. Lucie River and other bodies of water in the county. High temperatures, heavy rainfall and the high water levels in Lake Okeechobee contributed to the algae’s growth, said Deborah Drum, the county’s manager of ecosystem restoration and management engineering.

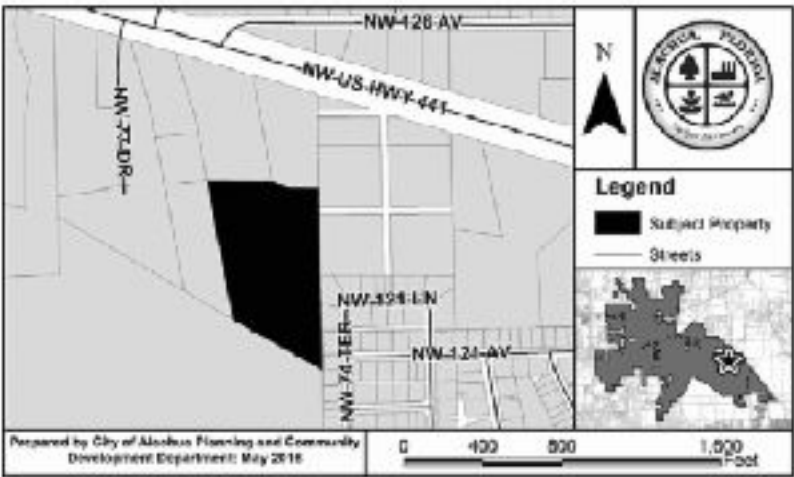

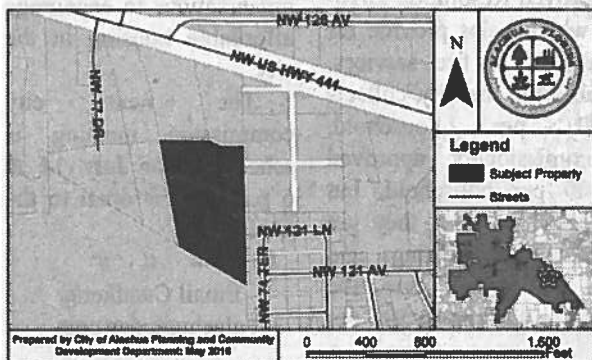

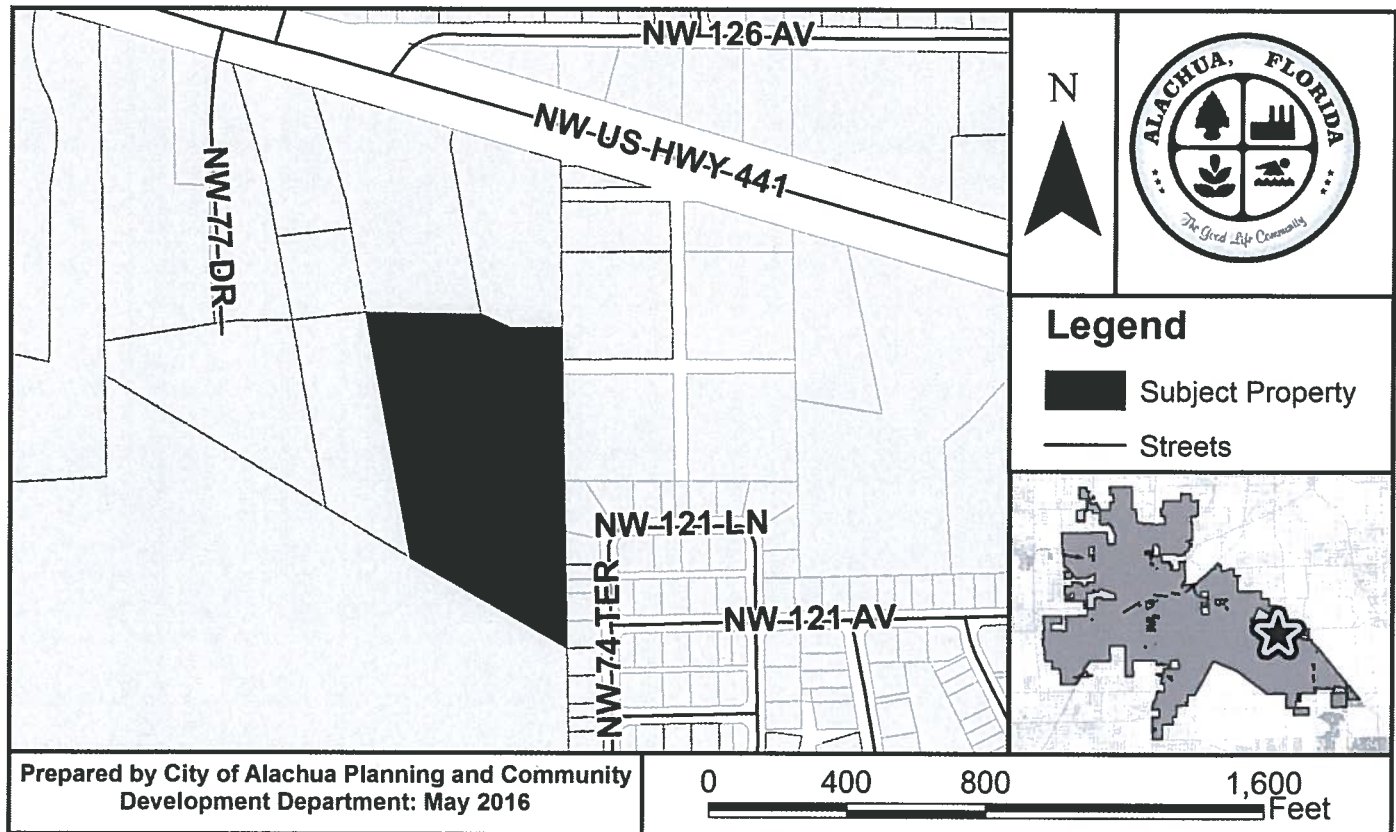
