The crash killed all 92 people on board and many more inside the tower.

Eighteen minutes later, United Airlines Flight 175 crashed into floors 75-85 of the WTC's South Tower killing 65 people on board and hundreds more inside the tower.

In addition to the deaths associated with the WTC, Flight 77 crashed into the western facade of the Pentagon in Washington, D.C., killing 59 aboard the plane and 125 military and civilian personnel inside the building.

After passengers and crew members aboard the hijacked Flight 93 learned about the attacks in New York and Washington, they mounted an attempt to retake the plane. In response, hijackers deliberately crashed the plane into a field in Somerset County, Pennsylvania, killing all 40 passengers and crew aboard.

At the ceremony, a moment of silence, coordinated via radio with the Alachua County Sheriff's Office, followed. High Springs Police Department (HSPD) Lt. Antoine Sheppard read aloud the inscription on the monument, which was followed by the placement of a wreath at the monument by HSFD Chief Bruce Gillingham.

HSPD Chief Joel DeCoursey, Jr., Sheppard and Gillingham did a slow salute, holding it while "Taps" were being played by Santa Fe High School student Emilee Jones. At the end of "Taps," the salute was slowly lowered.

Mayor Byran Williams spoke followed by a prayer by Gene Levine. High Springs Community School student Kiyana Williams then sang the "National Anthem." Gillingham and DeCoursey addressed the visitors and the ceremony ended with Kiyana

Williams singing "God Bless America."

Carrero sought and received permission from city commissioners to conduct the re-dedication ceremony and also install a garden with donations of plants and labor.

"With the generous donations from the citizens of High Springs and the donation of flowers and mulch we have created a beautiful garden surrounding the monuments," said

Carrero.

Most of the work preparing Memorial Gardens was done by Harry Patterson, who also purchased at least half of the plants in the garden area. He, Carol Pratt, Sue Weller, members of the HSFD and Carrero volunteered their time to create the garden. "We are all very proud of how it turned out," said Carrero.

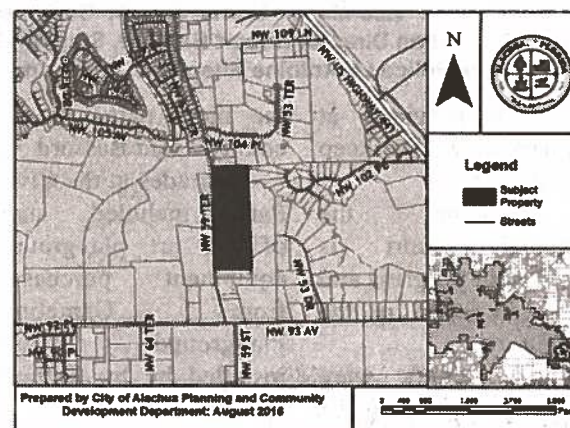

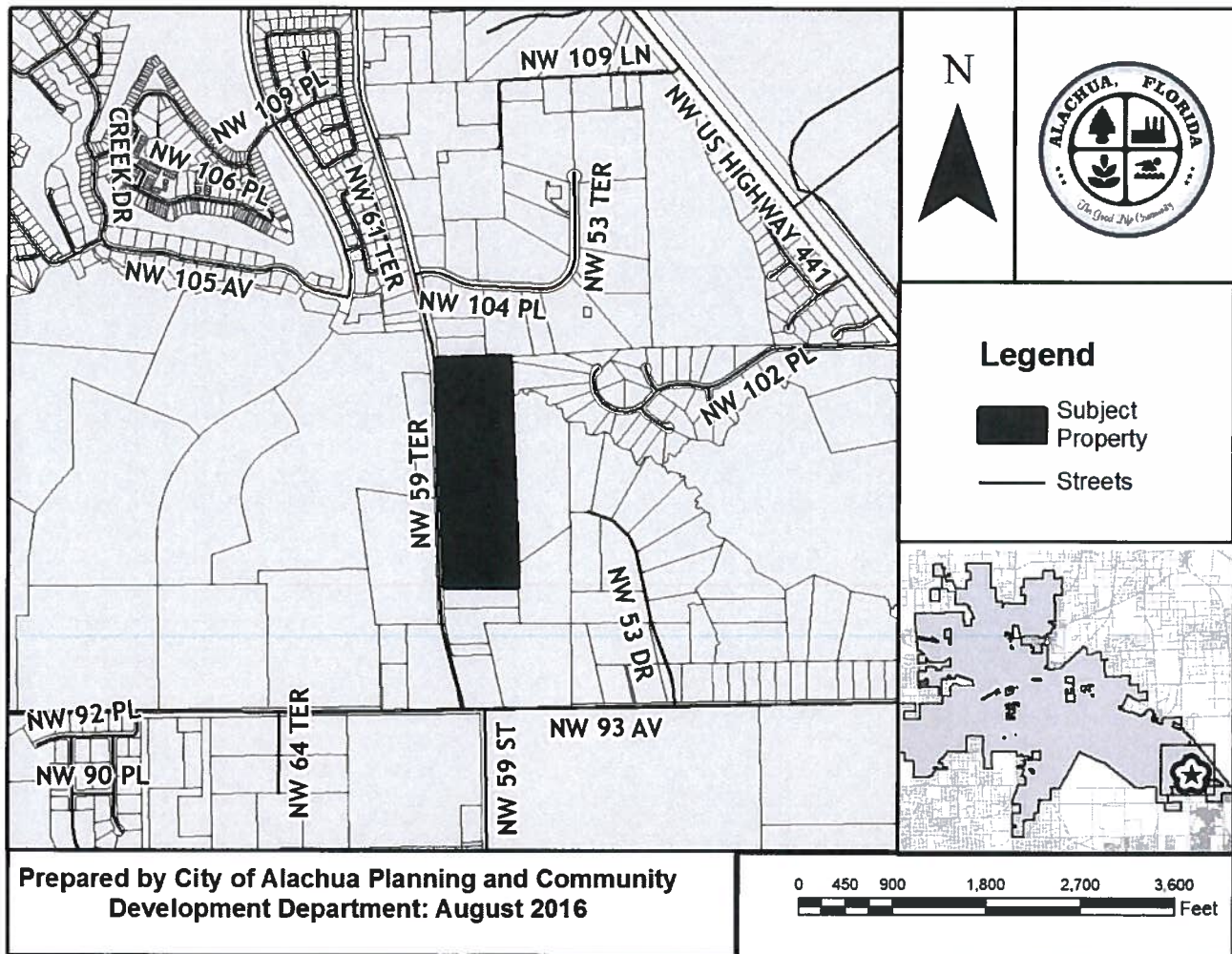
