# **PREAMBLE**

This agreement is entered into between the City of Alachua (The City") and the Gator Lodge 67, Fraternal Order of Police, Inc. ("FOP" or "the Union"). The "Police Department" referenced in this Agreement is the Alachua Police Department; hereinafter APD, of the City of Alachua, Florida.

It is the intent and purpose of the City and the FOP to set forth herein their entire agreement concerning wages, hours, and other terms and conditions of employment. There shall be no individual arrangement contrary to the terms of this Agreement.

The words "employee" and "member" are used interchangeably throughout this Agreement. These words are synonymous and refer to employees of the City of Alachua Police Department who are members of the bargaining unit covered by this Agreement.

This Agreement is primarily intended to promote the interests of the citizens of Alachua and the public in general and having at all times available to them services on the most efficient and economical basis practically achievable. The City, the FOP, and each member of the bargaining unit agree to use their best efforts to serve the citizens of the City and the public in general, to see that the public is served efficiently and with dedication to its interests, to assure that the services of the City are provided without interruption and with the highest standards of proper public performance.

It is contemplated that this Agreement will serve the public interest by maximizing the efficiency and productivity of employees of the Alachua Police Department by insuring that members of the bargaining unit will at all times be responsive to and make every reasonable effort to carry forward the City's legitimate activities and functions with promptness and dispatch, and will accept and execute promptly all instructions and orders given to them; and by defining the City's obligations to the FOP and members of the bargaining unit, and the FOP and members of the bargaining unit's obligations to the City, thus avoiding disputes; and to provide a procedure for the resolution of claims that this Agreement has been violated by either party, without any interruption of, or other interference with, the operation of the Police Department.

"Days" in this Agreement means working days during a pay period.

2		RECOGNITION

6	1.1	The City hereby recognizes the Gator Lodge 67, Fraternal Order of Police, Inc., hereafter referred
7		to as the FOP to be the exclusive bargaining representative for all matters affecting wages, hours,
8		and working conditions for those employees in the unit certified by the Public Employees
9		Relations Commission. Certification Number 1791
10		Included: All employees of the City of Alachua Police Department in the
11		classification of communications operator, patrolman, and sergeant.
12		Excluded: All other employees of the City of Alachua Police Department, excluding
13		specifically the police chief, the assistant chief, and the communications supervisor,
14		and all other employees of the City of Alachua.
15	1.2	It is further understood and agreed that the FOP shall designate, in writing, those individuals who
16		may speak on its behalf in any matter between the FOP and the City; however, such matters shall
17		include only those matters with which the FOP has the authority regarding its membership. Any
18		written notice designating any individual to speak on behalf of the FOP shall state the period of
19		time for such designation. Furthermore, a written list of the officers and representatives of the
20		FOP, and those individuals who are authorized to speak on behalf of the FOP, shall be furnished
21		to the Chief of Police immediately upon their designation and the Chief of Police shall be notified,
22		in writing, of any changes of said representative within five (5) days of such change.
23	1.3	Nothing in this Article, however, shall prohibit any member of the bargaining unit from
24		discussing any concern, complaint or suggestion with his or her supervisor, Division Commander
25		or Chief of Police.
26		Article 2
27		GRIEVANCE AND ARBITRATION PROCEDURE
28		
29 30	2.1	In a mutual effort to provide a harmonious working relationship between the parties to this
31		Agreement, it is agreed and understood that there will be procedure for the resolution of
32		grievances between the parties and that such procedure shall cover grievances involving

discharge, suspension, demotion, or any other adverse personnel action against a member covered
by this Agreement or any other dispute between the City and one or more employees concerning
the interpretation or application of, or compliance with the agreement including disputes
regarding discipline. The discharge, discipline, demotion, layoff or suspension of
probationary/training employees on initial hire or rehire shall not be subject to the grievance
procedure of this Agreement.

- Every effort will be made by the parties to settle any grievance as expeditiously as possible. Any grievance not answered by Management within the prescribed time limits shall automatically advance to the next higher step. Should the grieving party fail to observe the time limits as set forth in the steps of this Article, grievance shall be considered conclusively abandoned.
- 2.3 Grievances shall be presented in the following manner:
- Employee shall first take up grievance with the immediate supervisor within five (5) working Step 1: days of the occurrence of the event(s) which gave rise to the grievance or from the date which the employee becomes knowledgeable of the cause of action. If the event which gave rise to the grievance occurred at a time when the employee was on annual leave, sick leave or other compensated leave, the five (5) working day period shall commence running immediately upon the employee's return from such compensated leave. The first step shall be on an informal and oral basis. The FOP representative may be present to represent the employee. The immediate supervisor shall render decision within five (5) working days.
  - Step 2: Any grievance which cannot be satisfactorily settled with the immediate supervisor shall be reduced in writing by the employee or a FOP representative and shall next be taken up with the Chief of Police through the grievant or the representative of the FOP and the Chief of Police within five (5) working days after completion of Step 1. The Chief of Police shall within five (5) working days after discussion render decision in writing, with a copy to the employee's organization.
  - **Step 3:** Any grievance not satisfactorily settled at Step 2 will be taken up with the City Manager or designee with five (5) days from the date the Chief of Police has rendered decision. The grievance as specified in writing shall be discussed by and between the employee and

representative of the FOP and the City Manager within five (5) working days after completion of Step 2. The City Manager shall, within five (5) working days, render a written decision.

Arbitration: In the event a grievance processed through the grievance procedure has not been resolved at Step 3 above, the FOP and/or the grievant may request that the grievance be submitted to arbitration within fifteen (15) working days after the City Manager renders a written decision on the grievance. The arbitrator will be any impartial person mutually agreed upon by and between the parties. If an impartial arbitrator cannot be mutually agreed upon within fifteen (15) days after the grievance is submitted to arbitration, then the parties shall jointly request the Federal Mediation and Conciliation Service to furnish a panel of seven (7) names from which each party shall have the option within five (5) days of receipt by striking three (3) names in alternating fashion, with the grieving party striking first.

- A. The City and the FOP and/or grievant shall attempt to mutually agree in writing as to the statement of the grievance to be arbitrated prior to the arbitration hearing, and the arbitrator thereafter, shall confine decision to the particular grievance thus specified. In the event the parties fail to agree on the statement of the grievance to be submitted to the arbitrator, the arbitrator will confine consideration and determination to the written statement of the grievance presented in Step 3 of the grievance procedure.
- B. The arbitrator shall fashion, an appropriate remedy for violations of the provisions contained in this Agreement.
- C. The arbitrator shall have no authority to change, amend, add to, subtract from, or otherwise alter or supplement this Agreement to any part thereof or amendment thereto. The arbitration hearing shall be conducted in accordance with the Rules of Procedure promulgated by the Federal Mediation and Conciliation Service.
- D. Each party shall bear the expense of its own witnesses and of its own representatives for purpose of the arbitration hearing. The impartial arbitrator's fee and related expenses and expenses of obtaining a hearing room, if any, shall be equally divided between the parties. Any party desiring a transcript of the hearing shall bear the cost of such transcript unless both parties mutually agree to share said cost.

1		E. Copies of the arbitrator's award shall be furnished to both parties within thirty (50) days
2		of the close of the arbitration hearing. The arbitrator's award shall be final and binding
3		on the parties.
4		F. Where a grievance is general in nature, in that it applies to a number of employees rather
5		than a single employee, or if the grievance is directly between the FOP and the City,
6		such grievance shall be presented by the FOP Representative, in writing, directly to the
7		City Manager, (Step 3) within ten (10) working days of the occurrence of the event(s).
8		G. All above-mentioned time frames may be extended in writing by mutual agreement.

10 11		<u>DUES DEDUCTION</u>
12	3.1	Any member of the Bargaining Unit may have membership dues deducted from wages. Dues
13		shall be deducted once each month and shall thereafter be transmitted to the FOP, accompanied
14		by a list of those employee's names whose dues are included.
15	3.2	The FOP agrees to indemnify, defend and hold the City harmless against any and all claims, suits,
16		orders of judgments brought or issued against the City as a result of any action taken or not taken
17		by the City under the provisions of this Article.

20 21 22		MANAGEMENT RIGHTS
23 24	4.1	It is the right of the Employer to determine unilaterally the purpose of each of its constituent
25		agencies, set standards of services to be offered to the public and exercise control and discretion
26		over its organization and operations.
27	4.2	In addition, the FOP recognizes the sole and exclusive rights, powers and authority of the
28		Employer further include, but are not limited to, the following: to direct and manage employees
29		of the City; to hire, promote, transfer, schedule, assign and retain employees, to suspend, demote,
30		discharge or take other disciplinary action against employees for proper cause; to relieve
31		employees from duty because of lack of work, funds, or other legitimate reasons; to maintain the
32		efficiency of its operations including the right to contract and subcontract existing and future

work; to determine the duties to be included in job classifications and the numbers, types and grades of positions or employees assigned to an organizational unit, department or project; to assign overtime and to determine the amount of overtime required, to control and regulate the use of all its equipment and property; to establish and require employees to observe all its rules and regulations, to conduct performance evaluations; and to determine internal security practices. The Employer agrees that, prior to substantial permanent lay-off of FOP bargaining unit members, it will discuss such with the FOP.

If, in the sole discretion of the City Manager/Designee, it is determined that civil emergency conditions exist, including, but not limited to, riots, civil disorders, severe weather conditions (or similar catastrophe), the provisions of this Agreement may be suspended by the City Manager/Designee during the time of the declared emergency, provided that wage rates and monetary fringe benefits shall not be suspended. Should an emergency arise, the FOP shall be advised as soon as possible of the nature of the emergency.

## Article 5

# PERSONNEL RECORDS

5.1

Each employee covered by this Agreement shall have the right to inspect his or her official personnel file, provided, however, that such inspection shall take place during working hours at the location where the official personnel file is kept. The employee shall have the right to make duplicate copies of any items contained in his or her official personnel file.

Employees shall have the right to file a written response to any letter of reprimand or to any document which is placed in the employee's official personnel file as a result of supervisory action or citizen complaint. At the employee's request any such written response shall be included in the employee's official personnel file together with the letter of reprimand or other document against which it is directed.

5.3 To the extent permitted by law and in order to protect the privacy and promote the safety of individual police officers, the City agrees not to directly or indirectly furnish the news media or the public with any employee's home address, telephone number **or** photograph.

The FOP agrees not to directly or indirectly furnish the news media or the public with personnel records without the consent of the City and the employee thus insuring the confidentiality of personnel records other than required by law.

## Article 6

# **SENIORITY**

The City agrees that seniority shall consist of continuous accumulated paid service with the City. It shall be computed from the date probation is completed in rank or classification. Members serving in a higher rank or classification shall have seniority over those of lower rank or classification. Seniority shall accumulate during leaves of absence due to injury, illness, vacation, or any other leave authorized and approved by the City.

6.2 Vacation periods for each calendar year shall be drawn by employees on the basis of seniority.

In the event of a layoff for any reason, employee performance evaluations will be the determining factor used by the City. In the event that more than one employee has the same performance evaluation, employees will be laid off in the inverse order of their seniority. Any employee to be laid off, who has advanced to present classification from a lower classification, in which he or she held a permanent appointment, shall be given a position in a lower classification in the same department. His or her seniority in the lower classification shall be established according to the date of permanent appointment with the Police Department. No new employee shall be hired in any classification until all employees on layoff status in that classification have had an opportunity to return to work. Employees shall be called back from layoff with the performance evaluation being the determining factor. In the event that more than one employee has the same performance evaluation, employees will be recalled according to the seniority in the classification from which the employee was laid off.

1	6.4	Employees shall be notified of their recall to work by registered letter mailed to their address or
2		record and shall be given fifteen (15) calendar days to return to work. A recalled employee shall
3		notify the employer in writing of the employee's intent to return to work within five (5) calendary
4		days of notice of attempt to deliver the recall letter.
5	6.5	An employee laid off pursuant to this Article, provided the insurance carrier concurs, shall be
6		given the opportunity to continue insurance coverage in existing programs during the layof
7		provided that the premiums for such insurance programs shall be paid by the employee on a
8		monthly basis in advance of the month due.
9	6.6	Recall will be the current rate of pay for classification but not lower than when the employee was
10		laid off. Upon recall, all credit for seniority shall be restored.
11		In the event of a vacancy in a Department or Division, and/or a promotional vacancy, seniority
12		will be given reasonable consideration, but will not be the determining factor.
13	6.7	Seniority shall also be considered in the selection of any employee to be sent to any type or
14		schooling.

17		LEAVE OF ABSENCE

20 21	7.1	Leave of Absence Without Pay:

The decision to grant leave without pay (leave of absence) is a matter of administrative discretion. It shall be incumbent upon the Chief of Police to weigh and determine each case on its own merits. Any leave of absence for a period of thirty (30) days or more must have the approval of the City Manager. Failure of any employee to return to duty upon expiration of his/her leave of absence shall constitute the resignation of that employee. Holidays, sick leave, annual leave and any other benefits based on time spent in the employment of the City shall not accrue during a leave of absence without pay provided, however, that the employee may maintain health insurance coverage by paying the total cost of his/her group insurance premium. Longevity increases, merit increases and any other increases for which an employee may become eligible based on whole, or

1		in part on length of service with the City shall not be credited during any period of leave of absence
2		without pay.
3		A. An employee shall return from leave of absence to the same step of his/her salary
4		grade as at the time of commencement of leave of absence.
5		B. Any employee who is a member of the National Guard or an organized military service
6		unit of the United States will be allowed a leave of absence with pay when called to
7		active duty or for training with the armed forces in accordance with State and Federal
8		Law.
9	7.2	General
10		An employee shall return from any leave of absence to the same step of his/her salary grade as at
11		the time of commencement of the leave of absence.
12		Military leave shall be granted in accordance with the provisions of State and_Federal Law. All
13		employees entitled to military leave shall give their supervisor an opportunity, within the limits of
14		military regulations, to determine when such leave shall be taken.
15	7.3	Leave of Absence With Pay
16		Leave with pay for sufficient cause (including illness) may be granted to regular employees of the
17		City, by the City Manager, up to an including five (5) consecutive working days in any twelve-
18		month period. More extended periods of leave with pay may not be granted except by express
19		approval of the City Commission. This provision is applicable only if all accrued vacation time is
20		exhausted.

24		PROBATIONARY /TRAINING PERSONNEL

25 26	8.1	All new members and those who have been promoted to a higher classification or rank shall serve
27		a probationary/training period of 365 days, which can be extended for up to 6 months at the
28		discretion of the Chief of Police, during which time they shall not be entitled to any seniority
29		rights but during such period shall be subject to all terms and conditions of this Agreement.

1	8.2	Upon successful completion of said 365 days or such period of extension as provided for in 8.1,
2		new, employees shall be shown as regular full time employees. Those promoted in classification
3		or to Sergeant shall accrue seniority in classification or rank from the date of successful
4		completion of the probationary/training period.
5		Article 9
6 7 8 9		BULLETIN BOARDS
10	9. 1	The City agrees to provide a bulletin board for FOP use at the APD Police Station.
11	9. 2	The City shall permit the FOP to post notices of the FOP's business and matters relating to the
12		administration of this Agreement.
13	9.3	The City will post any proposed changes to Policies and Procedures on the FOP Bulletin Board as
14		Provided in Article 13.4 at least 30 days prior to effective date of the proposed changes, as
15		provided in Article 13.4.
16	9.4	The City shall create a FOP intranet portal where the FOP can post approved material for
17		bargaining unit members.
18	9.5	The City will also post notices to FOP and unit members on the site.
19	9.6	The City will post, thirty (30) days in advance of the projected assignment date, all opportunities
20		for lateral transfer to new or open positions. Posting will be on the FOP Bulletin Board and all
21		interested and eligible bargaining unit members shall submit by email to the Chief of Police the
22		written reasons for the request, qualifications and other support for transfer to the assignment. All
23		Such requests shall be received by the Chief, as evidenced by proof of sending the email on the
24		City IT System to the Chief, fourteen (14) days before the published assignment date. The Chief
25		of Police, as provided for in Article 4, will consider all such requests and make the final staffing
26		decision and selection from the members of the entire bargaining unit as the Chief determines to
27		be in the best interests of the City.

1		Article 10
2		VOTING/POLITICAL ACTIVITY
3 4	10.1	During a primary, general, or special election, an employee who is a registered voter whose hours
5		of work do not allow sufficient time for voting shall be expected to take advantage of early voting,
6		absentee ballot or other options available to the public.
7	10.2	Employees will be allowed to engage in the full range of political activities guaranteed to all
8		citizens while off duty and not in uniform.
9		
10		Article 11
11		INTERNAL INVESTIGATIONS & OBLIGATIONS TO THE PUBLIC
12	11.1	The parties recognize that the security of the City and its citizens depends to a great extent upon
13		the manner in which the employees covered by this Agreement perform their various duties.
14		Further, the parties recognize that the performance of such duties involves these employees in all
15		manner of contacts and relationships with the public and out of such contact and relationships,
16		questions may arise or complaints may be made concerning the actions of employees covered by
17		this Agreement. Investigation of such questions and complaints must necessarily be conducted by
18		a sworn law enforcement officer whose concern must be the security of the City and preservation
19		of the public interest.
20		In order to maintain the security of the City and protect the interests of its citizens, the parties
21		agree that the City must have the unrestricted right to conduct investigations of citizens'
22		complaints and matters of internal security; provided, however, that any investigative
23		interrogation of any employee covered by this Agreement relative to a citizen's complaint and or
24		a matter of internal security shall be conducted under the following conditions and following the
25		provisions of F.S.S. 112, the Police Officer's Bill of Rights.
26		A. No employee shall be ordered to submit to any device designed to measure the truth of
27		his/her responses during questioning, provided, however, that there shall be no restriction
28		on the right of any employee to submit to such device on a voluntary basis.

1	B.	In the interest of internal security and fairness to the employee under investigation, the
2		City insofar as is legally permissible, agrees to make no conclusionary public statements
3		concerning the validity of the allegations under investigation until such time as the
4		investigation has been completed. In the event the employee under investigation, or any
5		organization or person representing said employee makes public statement concerning the
6		allegations under investigation, the City shall have the right to respond in any manner it
7		deems appropriate.
8	C.	In all cases wherein an employee is to be interrogated concerning an alleged violation of
9		the Department's Rules and Regulations which, if proved, may result in dismissal or in
10		some other disciplinary measure, he shall be afforded a reasonable opportunity and
11		facilities to contact and consult privately with an attorney of his/her choosing and the
12		representative of the FOP, who may be present during all interrogation. The attorney and
13		their FOP representative may be present during the interrogation. When the attorney
14		and/or representative is not immediately available and conditions permit, the
15		interrogation will be postponed for twenty-four (24) hours or to a date mutually agreed
16		upon.
17	D.	In cases where the City chooses to relieve an employee from duty pending an
18		investigation or other administrative determination, the following conditions will prevail:
19		The employee will remain on full salary and allowances and shall not lose any benefits
20		during this period of time.
21		Should disciplinary action result from the investigation, that period of time in which the
22		employee was relieved from duty will be included in disciplinary action. In the event that
23		an employee has been paid, the employee's accumulated leave or compensatory time
24		shall be charged as a set-off.
25	E.	The findings of internal affairs investigations shall be labeled:
26		1. Unfounded – The act or acts complained of did not occur or did not involve APD

personnel.

1			2. Not-sustained – Insufficient evidence to clearly prove or disprove the
2			allegation/complaint.
3			3. Sustained – The preponderance of evidence clearly proves the
4			allegation/complaint.
5			4. Exonerated – The act or acts did not occur, but were justified, lawful and proper.
6			5. Exonerated due to policy failure – A finding of conclusion that policy,
7			procedure, rule or regulation covering the situation was non-existent or
8			inadequate.
9		F.	Only "Sustained" complaints will be inserted in an officer's personnel file.
10		G.	The charge "conduct unbecoming an officer" can be used provided it is qualified by "in
11			that the officer did (describe the conduct in detail)."
12		Н.	The City shall not discharge or discipline any bargaining unit employee without proper
13			cause and due process, except in layoff situations (Article 4 and Article 6).
14	11.2	If th	ne City feels there is proper cause for disciplinary action the employee will be notified in
15		writin	g that he will be disciplined clearly stating the reasons therefore,
16		A.	In the event an employee becomes the subject of a formal Departmental or City
17			investigation arising from a complaint or allegation, the Department or the City,
18			whichever is appropriate, shall notify the employee of the complaint unless a criminal
19			investigation is initiated.
20		B.	Upon conclusion of the formal investigation the employee will be notified of the
21			disposition of the complaint.
22			Article 12
23			<u>LEGAL BENEFITS</u>
24	12.1	The C	ity will defend employees against any legal actions against them as a result of their actions
25		while	acting in the scope of their employment (i.e. in the line of duty), unless such employee
26		acted	in had faith or with malicious purpose or in a manner exhibiting wanton and willful

disregard of human rights, safety or property (acting outside legal authority).

The City agrees to indemnify all employees against judgments levied against them as a result of their actions while acting in the scope of their employment, unless the employee acted in bad faith or with malicious purpose or in a manner exhibiting wanton and willful disregard of human rights, safety or property (outside legal authority).

# **DISCIPLINE, RULES AND REGULATIONS**

13.1

It is agreed that employees covered by this Agreement shall be subject to the City of Alachua Personnel Policies and Procedures and the Alachua Police Department Operations Manual as either one now exists or may be amended. Should there be any conflict between the provisions of the Operations Manual and the City's Personnel Policies and Procedures, the City's Personnel Policies and Procedures shall prevail. This Agreement shall prevail in any conflict with either the Alachua Police Department Operations Manual or the City of Alachua Personnel Policies and Procedures.

Failure of employees to comply with the terms of the City's Personnel Policies and Procedures and the Police Department Operations Manual may result in the imposition of disciplinary action pursuant to the provisions of these above cited Rules.

It is the understanding and the intention of the parties that any disciplinary action taken in the case of an employee in this bargaining unit shall be subject to the grievance procedure as provided in Article 3-2 of this Agreement.

New or revised rules implemented within the Police Department Operations Manual and any

New or revised rules implemented within the Police Department Operations Manual and any changes in the City of Alachua Personnel Policies and Procedures, shall be posted on the FOP bulletin board at least 30 days prior to the effective date if the proposed changes in Policy and Procedures will impact wages, hours or terms and conditions of employment. If the FOP disagrees with a new Police Department rule or City Personnel Policies and Procedures, it shall make a written request for a meeting with the designated city bargaining representative to attempt to

1		reach a mutual agreement. The FOP request shall be shall be delivered to the designated city
2		bargaining representative and the meeting shall be held prior to the proposed effective date of
3		such rule. The 30 day posting requirement may be waived by mutual agreement between the
4		local FOP Representative and the City Representative.
5	13.5	A copy of the City Personnel Policies and Procedures is issued to each member and on file at the
6		Police Department for the information of all department personnel.
7		Article 14
8		TEMPORARY ASSIGNMENT TO A HIGHER CLASSIFICATION
9	14.1	Employees temporarily serving (acting) in a position of higher rank shall be paid for such hours at
10		the minimum rate of the position being filled or at least five percent (5%) higher than the
11		employee's base rate, whichever is greater.
12		
13		Article 15
14		<u>TRAINING</u>
15	15.1	
16	15.1	Where the City requires any employee to attend supervisory training and/or training in specialized
17		techniques, the City will make every reasonable effort to facilitate the employee attending such
18		training during normal working hours. In the event the City is unable to schedule the employee to
19		attend such training during normal working hours, the employee shall be required to attend such
20		training during off-duty hours. However, the time spent by the employee in such training during
21		off-duty hours shall be compensated in accordance with Hours of Work and Overtime.
22	15.2	All sworn officers will be required to train and qualify with their service weapon on a semi-annual
23		basis. The training will be conducted by a certified firearms instructor. All ammunition and
24		safety equipment will be furnished by the City. Any employee required to attend such training
25		during off-duty hours will be compensated in accordance with Hours of Work and Overtime. An

employee will be required to post a score of at least seventy-five (75%) to qualify. Any employee

posting a score of ninety-two percent (92%) or better, two consecutive semiannual times, will

1		receive a bonus of one day of paid leave, not charged against any other leave time, to be taken by
2		employee at any time, with approval of the supervisor.

19		event of any violation(s) of this section, the City shall be entitled to seek and obtain immediate
20		injunctive relief.
21		"Picketing" as used herein shall mean any action which has the effect of preventing or attempting
22		to prevent employees from reporting to or continuing work or preventing the public from entering
23		public facilities. Informational picketing is allowed.

25		PROMOTION TO SERGEANT
26		EXAMINATION PROCESS
27 28	30.1	Promotions to Sergeant in the Department shall be filled as established in this Article.

1 30.2 The City will post, on all department bulletin boards, (for all eligible officers) a date for a 2 competitive promotional examination. The City will give forty-five (45) days notice prior to the commencement of the examination(s) and provide a list from where the questions are to come for 3 4 the written examination. 5 30.3 Officers, to be eligible to take the exam for Police Sergeant, shall have a minimum of three (3) years of continuous satisfactory full time service as a Police Officer with the City of Alachua or 6 at least two years of continuous satisfactory certified sworn law enforcement service 7 with another agency in the state of Florida the 36 months preceding the date of hire 8 by APD, satisfactorily completed the APD probation/training period and served one 9 10 year continuously with APD after completion of probation./training. 30.4 The competitive process will consist of four (4) phases, a written multiple choice exam, a 12 practical exercise, role playing and an oral board. An employee will have to obtain a score of at 13 least 70% on the written exam to continue to the next stage of the process. The written test will 14 consists of 100 multiple choice questions and the score is valid for two full years from the date of 15 taking. However, if an officer elects to retake the written test when it is offered, only the more 16 recent test score will be valid. The practice exercise will consist of presenting the officer with a 17 simulated event and then requiring the officer to complete the required report(s) in order to 18 evaluate the candidate's perception, knowledge and report writing skills. The third phase involves the candidate in a role playing exercise. The exercise is designed to evaluate the candidate's 19 knowledge, judgment, composure, interpersonal skills, leadership and decision making. The 20 practice exercise and role playing phase may be combined. The final phase consists of an oral 21 22 board made up of the three (Sergeants or lieutenants or any combination) from law enforcement 23 agencies in the state. The City will assemble and select the board and bear any associated costs 24 during the oral board. Candidates will be asked to respond to questions concerning situations a 25 Sergeant with APD would be expected to encounter. 26 Each phase (1-4) will be graded separately and weighted at 25 percent of the total score of 100 27 (25 points each).

1		All candidates will be given the same written exam (phase I), and presented with the same
2		practical exercise (phase II) and role playing scenario (phase III). The oral board will be
3		unscripted (phase IV).
4	30.5	The FOP may have one (1) proctor present during any part of the examination process (written
5		or oral). The proctor shall act as an observer and will not interfere with the examination.
6	30.6	The Chief of Police will be able to pick from the top three employees on the promotional list
7		when determining who is to be promoted. The promotional list shall be valid for 24 months
8		from the date of its inception. Should the City offer a new test before the expiration of the
9		promotional list, the officers on the current list shall have the option to re-test. The rankings
10		shall be from highest score to lowest and will incorporate officers from any and all current
11		testing cycles. However, officers will be deleted from the promotion list when their 24 month
12		eligibility expires. As officers are removed, those employees remaining on or added to the
13		promotional list from a new testing cycle will be ranked from the highest score to the lowest.

21		of its employees or members of the public or compromise the quality of our work, services or

23		physical faculties. Both parties agree to the promotion of a drug free workplace pursuant to
24		Florida State Statute 440.102 and Executive Order 12584 (Drugfree Workplace Act).

30		NON-DISCRIMINATION

2	32.1	Employees of the City shall have the right to form, join, and participate in, or to refrain from
3		forming, joining, and participating in any employee organization of their own choosing. No
4		employee shall be intimidated, restrained, coerced, or discriminated against by either the City or
5		the FOP, because of the exercise of these rights.
6	32.2	The City and the FOP shall apply the provisions of this Agreement equally to all employees
7		without discrimination, because of age, sex, race, creed, religion, national origin or disability
8		except where the law allows consideration of such factors.
9	32.3	The use of masculine or feminine gender in this Agreement shall be construed as including both
10		genders.
11		Article 33
12		<u>Safety</u>
13	33.1	It shall be the joint responsibility of the City of Alachua and the FOP to work cooperatively to
14		ensure the safest working environment possible.
15	33.2	The City and the FOP shall meet at least quarterly to discuss safety concerns; however, either
16		party may call a safety meeting at any time to discuss safety concerns.
