

RESOLUTION 16-20

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF ALACHUA, FLORIDA, APPROVING BRAMMER BIO, LLC AS A QUALIFIED TARGET BUSINESS INDUSTRY PURSUANT TO SECTION 288.106, FLORIDA STATUTES; AGREEING TO PAY UP TO TWENTY FIVE THOUSAND DOLLARS (\$25,000) TOTAL BEGINNING FY 2018/19 OVER A PERIOD OF FOUR YEARS FOLLOWING JOB CREATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the business under consideration, Brammer Bio, LLC, is a contract manufacturing company; and

WHEREAS, Brammer Bio, LLC proposes to expand its operations within the City of Alachua/Alachua County; and

WHEREAS, Brammer Bio, LLC, with the proposed selection of City of Alachua/Alachua County, will employ an additional 50 employees anticipated to begin hiring in FY 2017/18 with an average annual compensation of at least \$42,000 per year; and

WHEREAS, Brammer Bio, LLC will make a significant capital investment over the next three years; and

WHEREAS, the request by Brammer Bio, LLC has been reviewed by Enterprise Florida's primary economic development partner in Gainesville/Alachua County, the Gainesville/Alachua County Council for Economic Outreach and Gainesville Area Chamber of Commerce; and

WHEREAS, this resolution is required by section 288.106(4)(a)(10), Florida Statutes (2011); and

WHEREAS, THE GOVERNING BOARD OF THE CITY OF ALACHUA COMMISSION will contribute local financial support, specifically with the ALACHUA COUNTY BOARD OF COUNTY COMMISSIONERS, in the form of cash for the Qualified Target Industry Tax Refund; and

WHEREAS, the CITY OF ALACHUA COMMISSION acknowledges that its participation in the Qualified Targeted Industry Tax Refund program is required as a local government match and understands that its contribution to the program will be a maximum of TWENTY FIVE THOUSAND DOLLARS (\$25,000) over a period of four years anticipated to begin in FY 2018/19 following job creation; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF ALACHUA, FLORIDA:

Section 1. That the City Commission finds, determines, and declares that the recitals in the preamble are true and correct, and hereby incorporates them by reference.

Section 2. That the City Commission recommends that Brammer Bio, LLC be approved as a Qualified Target Industry Business pursuant to section 288.106(1)(0), Florida Statutes.

Section 3. BE IT FURTHER RESOLVED that the CITY OF ALACHUA COMMISSION has determined the basis of this project's average private sector wage commitment calculation shall be 115% of Alachua County's average annual wage.

Section 4. This resolution shall take effect immediately upon its adoption.
