#### IV. PUBLIC HEARINGS AND ORDINANCES

A. Resolution 16-24 Relating to the Levy of General City Purpose Ad Valorem Taxes for the 2016 Tax Year; Resolution 16-25 Relating to the City's Budget for the 2016-2017 Fiscal Year and Resolution; 16-26 Relating to the 2017-2021 Capital Improvement Program

Finance & Administrative Services Director Robert Bonetti introduced the item and provided the staff report.

Mayor Coerper called to order the Final Public Hearing on the City of Alachua Fiscal Year 2016-2017 Final Millage and Final Budget.

City Attorney Marian Rush provided an overview of the Truth-in-Millage Legislation (TRIM).

City Manager Gresham explained the General City Final and Rolled Back Millage Rates.

Finance & Administrative Services Director Bonetti presented an overview of the final budget and adjustments for Fiscal Year 2016-2017.

Mayor Coerper opened the floor for comments.

There were no comments.

Finance & Administrative Services Director Bonetti said the City of Alachua Fiscal Year 2016-2017 Final Budget document included the changes as he described in his overview.

## City Attorney Rush provided the reading of Resolution 16-24 by title only.

City Manager Gresham announced that the City of Alachua Commission has determined that a proposed millage rate of 5.9900 mills is necessary to fund the final general City budget. She said the proposed final millage rate represents an increase of 2.29% from the rolled-back rate of 5.8558 mills.

Vice Mayor Wilford inquired about unencumbered funds being carried forward. Finance & Administrative Services Director Bonetti said the funds were from unfinished projects. He said they were basically reserves being carried forward.

Commissioner Hardacre said he was pleased with the budget, and he was glad to see so many projects being funded.

## Commissioner Hardacre moved to adopt Resolution 16-24; seconded by Vice Mayor Wilford.

Mayor Coerper opened the floor for comments.

There were no comments.

## Passed 5-0 on roll call vote.

# City Attorney Rush provided the reading of Resolution 16-25 by title only.

Mayor Coerper asked the commissioners for questions or comments.

# City Attorney Rush provided the reading of Resolution 16-26 by title only.

Commissioner Boukari thanked Staff and citizens for their participation in providing a strong budget. He spoke of various projects completed, and put into place for the future, during the past year.

Finance & Administrative Services Director Bonetti said the budget was a group process. He thanked the commissioners, the city manager, and Staff.

City Manager Gresham said that the strategic planning undertaken by the commissioners greatly facilitated the budget process. She thanked Finance & Administrative Services Director Bonetti and Staff for the hard work.

B. Sanctuary Oaks Final Plat: A request by Causseaux, Hewett, & Walpole, Inc., applicant and agent for Pamela Neff, property owner, for consideration of the subdivision of a ±37 acre subject property into 6 lots. Tax Parcel No. 05936-004-000 (Quasi-Judicial Hearing)

City Attorney Rush announced this is a quasi-judicial proceeding.

Deputy City Clerk Henderson administered the oath for testimony.

City Planner Adam Hall introduced the item and provided the staff report.

Mayor Coerper asked the commissioners for questions or comments.

The commissioners engaged in discussion on wells, septic tanks, the City water system, buffering, flood zones, stormwater runoff, and building permits.

<u>Commissioner Boukari moved that based upon the competent substantial evidence presented at this hearing, the presentation before this Commission, and Staff's recommendation to approve the Final Plat of Sanctuary Oaks ("Final Plat") and the "Certificate of Concurrency Compliance for Sanctuary Oaks" ("Certificate of Concurrency Compliance"); to authorize the Mayor to sign the Final Plat and and Certificate of Concurrency Compliance acknowledging the Commission's approval; and to authorize the City Attorney to sign the Final Plat and Certificate of Concurrency Compliance, approving their legal form and sufficiency; seconded by Commissioner Brown.</u>

Mayor Coerper opened the floor for comments.

There were no comments.

C. Ordinance 16-17; Second and Final Reading, Amending and Restating in Total Chapter 30 - Solid Waste

# VII. COMMENTS FROM CITY MANAGER AND CITY ATTORNEY

City Manager Gresham said the streets in Merrillwood subdivision are all completed as part of the CDBG Road project. She said work is being done on driveways and other areas and the project is moving forward. She thanked Staff for all of their work throughout the year and for the work completed in the budget.

City Attorney Rush said Myers Brothers, Inc., has applied for a septage application permit through the Department of Environmental Protection (DEP). She said the company has been in operation under the purview of the Department of Health. She said it seems the company is seeking to expand its current operations, and that if approved, it would in the future be regulated under the authority of the DEP.

She said the Notice of Intent to Issue a Permit from the DEP allowed for the request for a formal administrative hearing, or for an extension of time to request the hearing. She said that as the City has not had time to review the permitting or the issue, and after discussion with City Manager Gresham, she would like the City Commission to authorize her to file for the 30-day extension of time for requesting the hearing.

# <u>Vice Mayor Wilford moved to waive the Commissioners' Rules of Procedure and to authorize City Attorney</u> <u>Rush to submit a letter requesting a 30-day extension; seconded by Commissioner Brown</u>.

Mayor Coerper opened the floor for comments.

There were no comments.
