The City of Alachua plans to apply to the Florida Department of Economic Opportunity (DEO) for a FFY 2016 Small Cities Community Development Block Grant (CDBG) of \$700,000 in the Neighborhood Revitalization Category. The City will also pave NW 159th Lane. In addition to repaving, the City will provide approximately 6,700 LF of sidewalks along all or portions of the following streets: Hipp Way, Merrillwood Drive, NW 131st Ter, NW 132nd Dr, NW 132nd Ter, NW 133rd Ter, NW 134th Ter, NW 135th Ter, NW 150th Ave, NW 151st Ave, NW 151st Ln, NW 151st Pl, NW 152nd Pl, NW 153rd Ln, NW 153rd Pl, NW 154th Ave, NW 154th Ln, NW 154th Pl, NW 155th Ln, NW 155th Pl, NW 157th Ave, NW 157th Ter, NW 158th Ave.

The City of Alachua does not expect that anyone will be displaced as a result of CDBG-funded activities. If any persons are displaced as a result of the planned activities, the City of Alachua will assist them as described in the City's anti-displacement and relocation policy, which is available for review at City Hall.
