

RESOLUTION 17-09

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; APPROVING THE USE OF FORFEITURE FUNDS; AMENDING THE FISCAL YEAR 2016-2017 BUDGET; INCREASING THE GENERAL FUND BUDGET BY \$19,030, TO PROVIDE FOR UNANTICIPATED REVENUES AND EXPENSES RELATED TO THE USE OF FORFEITURE FUNDS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission approves and desires to utilize Forfeiture Funds for the purchase of law enforcement equipment – tasers, taser accessories and Automated External Defibrillators (AED's);

WHEREAS, it is necessary to increase the 2016-2017 General Fund budget in the amount of \$19,030, to reflect revenues and expenses associated with the unanticipated use of Forfeiture Funds for law enforcement equipment;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

- 1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2016-2017 Budget by the amount of nineteen thousand thirty dollars (\$19,030) as reflected in the budget amendment attached hereto as Exhibit A.
 - 2. That this resolution shall take effect immediately upon its adoption.
