

RESOLUTION 15-04

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE 2013-2014 BUDGET; RECOGNIZING UNANTICIPATED REVENUE IN THE GENERAL AND DCA HAZARD MITIGATION FUNDS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is necessary to increase the 2013-2014 General and DCA Hazard Mitigation Grant Funds budgets to reflect revenues and expenses associated with the receipt of unanticipated revenue from various sources (Licenses & Permits, Intergovernmental Revenue, Charges for Services, Court Fines, and Inter-fund Transfers; and,

WHEREAS, the City has received \$160,766 in unanticipated revenue and wishes to use said funds at this time to cover expenses related to public safety, physical environment, and recreation activities, thus avoiding large budget variances and allowing for the closing of the DCA Hazard Mitigation Grand fund.

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF ALACHUA, FLORIDA.

SECTION 1. The fiscal year 2013-2014 budget is amended to increase total revenues by \$160,766 and total expenditures \$160,766. The additional revenues and expenses are set out in the attached budget amendment (Exhibit A).

SECTION 2. That this resolution shall take effect immediately upon its adoption.
