

## **RESOLUTION 16-05**

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2015-2016 BUDGET; ESTABLISHING APPROPRIATION IN THE GENERAL FUND; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Alachua Police Department has been awarded a Justice Assistance Grant for the purchase of a Universal Forensic Extraction Device (UFED) and cloud analyzer; and,

WHEREAS, it is necessary to increase the Fiscal Year 2015-2016 General Fund budget in the amount of \$13,000 to reflect revenues and expenses associated with the receipt of the Justice Assistance Grant.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

- 1. The Fiscal Year 2015-2016 budget is amended to increase revenues and expenditures by the amount of \$13,000 as set forth in the budget amendment attached hereto as "Exhibit A".
- 2. That this resolution shall take effect immediately upon its adoption.
