PREAMBLE

This agreement is entered into between the City of Alachua (The City") and the Gator Lodge 67, Fraternal Order of Police, Inc. ("FOP" or "the Union"). The "Police Department" referenced in this Agreement is the Alachua Police Department; hereinafter APD, of the City of Alachua, Florida.

It is the intent and purpose of the City and the FOP to set forth herein their entire agreement concerning wages, hours, and other terms and conditions of employment. There shall be no individual arrangement contrary to the terms of this Agreement.

The words "employee" and "member" are used interchangeably throughout this Agreement. These words are synonymous and refer to employees of the City of Alachua Police Department who are members of the bargaining unit covered by this Agreement.

This Agreement is primarily intended to promote the interests of the citizens of Alachua and the public in general and having at all times available to them services on the most efficient and economical basis practically achievable. The City, the FOP, and each member of the bargaining unit agree to use their best efforts to serve the citizens of the City and the public in general, to see that the public is served efficiently and with dedication to its interests, to assure that the services of the City are provided without interruption and with the highest standards of proper public performance.

It is contemplated that this Agreement will serve the public interest by maximizing the efficiency and productivity of employees of the Alachua Police Department by insuring that members of the bargaining unit will at all times be responsive to and make every reasonable effort to carry forward the City's legitimate activities and functions with promptness and dispatch, and will accept and execute promptly all instructions and orders given to them; and by defining the City's obligations to the FOP and members of the bargaining unit, and the FOP and members of the bargaining unit's obligations to the City, thus avoiding disputes; and to provide a procedure for the resolution of claims that this Agreement has been violated by either party, without any interruption of, or other interference with, the operation of the Police Department.

"Days" in this Agreement means working days during a pay period.

2		RECOGNITION
3	1.1.	The City hereby recognizes the Gator Lodge 67, Fraternal Order of Police, Inc., hereafter referred
4		to as the FOP to be the exclusive bargaining representative for all matters affecting wages, hours
5		and working conditions for those employees in the unit certified by the Public Employees Relations
6		Commission. Certification Number 1791
7		Included: All employees of the City of Alachua Police Department in the classification
8		of communications operator, patrolman (police officer) I, II, III), and sergeant.
9		Excluded: All other employees of the City of Alachua Police Department, excluding
10		specifically the police chief, the assistant chief, lieutenants(s) and the communications
11		supervisor, and all other employees of the City of Alachua.
12	1.2.	It is further understood and agreed that the FOP shall designate, in writing, those individuals who
13		may speak on its behalf in any matter between the FOP and the City; however, such matters shall
14		include only those matters with which the FOP has the authority regarding its membership. Any
15		written notice designating any individual to speak on behalf of the FOP shall state the period or
16		time for such designation. Furthermore, a written list of the officers and representatives of the
17		FOP, and those individuals who are authorized to speak on behalf of the FOP, shall be furnished
18		to the Chief of Police immediately upon their designation and the Chief of Police shall be notified
19		in writing, of any changes of said representative within five (5) days of such change.
20	1.3	Nothing in this Article, however, shall prohibit any member of the bargaining unit from discussing
21		any concern, complaint or suggestion with his or her supervisor, Division Commander or Chief or
22		Police.
23	1.4	The terms Member and Employee are used interchangeably and refer to members of the certified
24		collective bargaining unit (BU).[GW1][GW2]

GRIEVANCE AND ARBITRATION PROCEDURE

- In a mutual effort to provide a harmonious working relationship between the parties to this Agreement, it is agreed and understood that there will be procedure for the resolution of grievances between the parties and that such procedure shall cover grievances involving discharge, suspension, demotion, or any other adverse personnel action against a member covered by this Agreement or any other dispute between the City and one or more employees concerning the interpretation or application of, or compliance with the agreement including disputes regarding discipline. The discharge, discipline, demotion, layoff or suspension of probationary/training employees on initial hire or rehire shall not be subject to the grievance procedure of this Agreement.
- 2.2 Every effort will be made by the parties to settle any grievance as expeditiously as possible. Any grievance not answered by Management within the prescribed time limits shall automatically advance to the next higher step. Should the grieving party fail to observe the time limits as set forth in the steps of this Article, grievance shall be considered conclusively abandoned.
- 2.3 Grievances shall be presented in the following manner:
- 16 Step 1: Employee shall first take up grievance with the immediate supervisor within five (5) working 17 days of the occurrence of the event(s) which gave rise to the grievance or from the date which 18 the employee becomes knowledgeable of the cause of action. If the event which gave rise to 19 the grievance occurred at a time when the employee was on annual leave, sick leave or other 20 compensated leave, the five (5) working day period shall commence running immediately upon 21 the employee's return from such compensated leave. The first step shall be on an informal and 22 oral basis. The FOP representative may be present to represent the employee. The immediate 23 supervisor shall render decision within five (5) working days.
 - **Step 2**: Any grievance which cannot be satisfactorily settled with the immediate supervisor shall be reduced in writing by the employee or a FOP representative and shall next be taken up with the Chief of Police through the grievant or the representative of the FOP and the Chief of Police within five (5) working days after completion of Step 1. The Chief of Police shall within five

1		(5) working days after discussion render decision in writing, with a copy to the employee's
2		organization.
3	Step 3:	Any grievance not satisfactorily settled at Step 2 will be taken up with the City Manager or
4		designee within five (5) days from the date the Chief of Police has rendered decision. The
5		grievance as specified in writing shall be discussed by and between the employee and
6		representative of the FOP and the City Manager within five (5) working days after completion
7		of Step 2. The City Manager shall, within five (5) working days, render a written decision.
8	Step 4:	Arbitration: In the event a grievance processed through the grievance procedure has not been
9		resolved at Step 3 above, the FOP and/or the grievant may request that the grievance be
10		submitted to arbitration within fifteen (15) working days after the City Manager renders a
11		written decision on the grievance. The arbitrator will be any impartial person mutually agreed
12		upon by and between the parties. If an impartial arbitrator cannot be mutually agreed upon
13		within fifteen (15) days after the grievance is submitted to arbitration, then the parties shall
14		jointly request the Federal Mediation and Conciliation Service to furnish a panel of seven (7)
15		names from which each party shall have the option within five (5) days of receipt by striking
16		three (3) names in alternating fashion, with the grieving party striking first.
17	1	A. The City and the FOP and/or grievant shall attempt to mutually agree in writing as to the
18		statement of the grievance to be arbitrated prior to the arbitration hearing, and the
19		arbitrator thereafter, shall confine decision to the particular grievance thus specified. In
20		the event the parties fail to agree on the statement of the grievance to be submitted to the
21		arbitrator, the arbitrator will confine consideration and determination to the written
22		statement of the grievance presented in Step 3 of the grievance procedure.
23]	3. The arbitrator shall fashion, an appropriate remedy for violations of the provisions
24		contained in this Agreement.
25	(C. The arbitrator shall have no authority to change, amend, add to, subtract from, or
26		otherwise alter or supplement this Agreement to any part thereof or amendment thereto.
27		The arbitration hearing shall be conducted in accordance with the Rules of Procedure
28		promulgated by the Federal Mediation and Conciliation Service.

1		D.	Each party shall bear the expense of its own witnesses and of its own representatives for
2			purpose of the arbitration hearing. The impartial arbitrator's fee and related expenses and
3			expenses of obtaining a hearing room, if any, shall be equally divided between the parties.
4			Any party desiring a transcript of the hearing shall bear the cost of such transcript unless
5			both parties mutually agree to share said cost.
6		E.	Copies of the arbitrator's award shall be furnished to both parties within thirty (30) days
7			of the close of the arbitration hearing. The arbitrator's award shall be final and binding
8			on the parties.
9		F.	Where a grievance is general in nature, in that it applies to a number of employees rather
10			than a single employee, or if the grievance is directly between the FOP and the City, such
11			grievance shall be presented by the FOP Representative, in writing, directly to the City
12			Manager, (Step 3) within ten (10) working days of the occurrence of the event(s).
13		G.	All above-mentioned time frames may be extended in writing by mutual
14			agreement.
15			Article 3
16			DUES DEDUCTION
17	3.1	Any m	ember of the Bargaining Unit may have membership dues deducted from wages. Dues shall
18		be ded	ucted once each month and shall thereafter be transmitted to the FOP, accompanied by a list
19		of thos	se employee's names whose dues are included.
20	3.2	The FO	P agrees to indemnify, defend and hold the City harmless against any and all claims, suits,
21		orders o	of judgments brought or issued against the City as a result of any action taken or not taken
22		by the C	City under the provisions of this Article.
23			Article 4
24			MANAGEMENT RIGHTS
25	4.1	It is the	e right of the Employer to determine unilaterally the purpose of each of its constituent
26		agencie	s, set standards of services to be offered to the public and exercise control and discretion

over its organization and operations.

In addition, the FOP recognizes the sole and exclusive rights, powers and authority of the Employer further include, but are not limited to, the following: to direct and manage employees of the City; to hire, promote, transfer, schedule, assign and retain employees, to suspend, demote, discharge or take other disciplinary action against employees for proper cause; to relieve employees from duty because of lack of work, funds, or other legitimate reasons; to maintain the efficiency of its operations including the right to contract and subcontract existing and future work; to determine the duties to be included in job classifications and the numbers, types and ranks of positions or employees assigned to an organizational unit, department or project; to assign overtime and to determine the amount of overtime required, to control and regulate the use of all its equipment and property; to establish and require employees to observe all its rules and regulations, to conduct performance evaluations; and to determine internal security practices. The Employer agrees that, prior to substantial permanent lay-off of FOP bargaining unit members, it will discuss such with the FOP.

4.3 Civil Emergency

<u>A.4.3 Civil Emergency</u>, if determined <u>ilf</u>, in the sole discretion of the City Manager <u>or</u> Designee and it is, it determined declared that civil emergency conditions exist, including, but not limited to, riots, civil disorders, severe weather conditions (or similar catastrophe), the provisions of this Agreement may be suspended by the City Manager <u>or</u> Designee during the time of the declared emergency, provided that wage rates and monetary fringe benefits shall not be suspended. Should an emergency arise, the FOP shall be advised as soon as possible of the nature of the emergency.

23 Article 5

PERSONNEL RECORDS

Each employee covered by this Agreement shall have the right to inspect his or her official personnel file, provided, however, that such inspection shall take place during working hours at the location where the official personnel file is kept. The employee shall have the right to make

1		duplicate copies of any items contained in his or her official personnel file.
2	5.2	Employees shall have the right to file a written response to any letter of reprimand or to any
3		document which is placed in the employee's official personnel file as a result of supervisory action
4		or citizen complaint. At the employee's request any such written response shall be included in the
5		employee's official personnel file together with the letter of reprimand or other document against
6		which it is directed.
7	5.3	To the extent permitted by law and in order to protect the privacy and promote the safety of
8		individual police officers, the City agrees not to directly or indirectly furnish the news media or the
9		public with any employee's home address, telephone number or photograph.
10	5.4	The FOP agrees not to directly or indirectly furnish the news media or the public with personnel
11		records without the consent of the City and the employee thus insuring the confidentiality of
12		personnel records other than required by law.

15	6.1	The City agrees that time in service shall consist of continuous accumulated paid service with the

8		be recalled according to the seniority in rank or classification from which the employee was laid

10	6.4	Employees shall be notified of their recall to work by registered letter mailed to their address of
11		record and shall be given fifteen (15) calendar days to return to work. A recalled employee shall
12		notify the employer in writing of the employee's intent to return to work within five (5) calendar
13		days of notice of attempt to deliver the recall letter.
14	6.5	An employee laid off pursuant to this Article, provided the insurance carrier concurs, shall be given
15		the opportunity to continue insurance coverage in existing programs during the layoff provided that
16		the premiums for such insurance programs shall be paid by the employee on a monthly basis in
17		advance of the month due.
18	6.6	Recall will be the current rate of pay for classification and rank but not lower than that of the
19		employee when laid off. Upon recall, all credit for seniority shall be restored.
20		In the event of a vacancy in an assignment, or a promotional vacancy, seniority will be given
21		reasonable consideration, but will not be the determining factor.
22	6.7	Seniority shall also be considered in the selection of any employee to be sent to any type of school
23		or training.
24		Article 7
25		LEAVE OF ABSENCE
26	7.1	Leave of Absence Without Pay:

The decision to grant leave without pay (leave of absence) is a matter of administrative discretion.
It shall be incumbent upon the Chief of Police to weigh and determine each case on its own merits.
Any leave of absence for a period of thirty (30) days or more must have the approval of the City
Manager. Failure of any employee to timely return to duty upon expiration of his/her leave of
absence shall constitute the resignation of that employee. Holidays, sick leave, annual leave,
seniority and any other benefits based on time spent in the employment of the City shall not accrue
during a leave of absence without pay provided, however, that the employee may maintain health
insurance coverage by paying the total cost of his/her group insurance premium. Longevity
increases, merit increases and any other increases for which an employee may become eligible based
on whole, or in part on length of service with the City shall not be credited during any period of leave
of absence without pay.
A. An employee shall return from leave of absence at the same rank and pay as at the time

- of commencement of leave of absence.
- В. Any employee who is a member of the National Guard or an organized military service unit of the United States will be granted a leave of absence when called to active duty or for training with the armed forces in accordance with State and Federal Law. Military leave shall be granted in accordance with the provisions of State and Federal Law. All employees entitled to military leave shall give their supervisor an opportunity, within the limits of military regulations, to determine when such leave shall be taken.

23	9.3	The City will post any proposed changes to City Policies and Procedures (COAPP) toor APD
24		Policies and Procedures in the Directive Management System (PDMS) Policies and
25		Procedures on the FOP Bulletin Board as Provided in Article 13.4 at least 30 days prior to effective
26		[GW7]date of the proposed changes, as provided in Article 13.4.

1	9. 4	The City has created a FOP_intranet portal where the FOP and City can post approved material for
2		bargaining unit members.
3	9.5	The City will also post notices to FOP and unit members on the site. [GW8]
4	9. <u>5</u> 6	The City will post, thirty (30) days in advance of the projected assignment date, all opportunities
5		for lateral transfer to new or open positions. Posting will be on the FOP Bulletin Board and all
6		interested and eligible bargaining unit members shall submit by email to the Chief of Police the
7		written reasons for the request, qualifications and other support for transfer to the assignment. All
8		Such requests shall be received by the Chief, as evidenced by proof of sending the email on the City

11		decision and selection from the members of the entire bargaining unit as the Chief determines to be
12		in the best interests of the City.
13		Article 10
14		VOTING/POLITICAL ACTIVITY
15	10.1	During a primary, general, or special election, an employee who is a registered voter whose hours of
16		work do not allow sufficient time for voting shall be expected to take advantage of early voting,
17		absentee ballot or other options available to the public.
18	10.2	Employees will be allowed to engage in the full range of political activities guaranteed to all citizens
19		while off duty and not in uniform.
20		Article 11
21		INTERNAL INVESTIGATIONS & OBLIGATIONS TO THE PUBLIC
22	11.1	The parties recognize that the security of the City and its citizens depends to a great extent upon the
23		manner in which the employees covered by this Agreement perform their various duties. Further,
24		the parties recognize that the performance of such duties involves these employees in all manner of
25		contacts and relationships with the public and out of such contact and relationships, questions may
26		arise or complaints may be made concerning the actions of employees covered by this Agreement.

Investigation of such questions and complaints must necessarily be conducted by a sworn law enforcement officer whose concern must be the security of the City and preservation of the public interest.

In order to maintain the security of the City and protect the interests of its citizens, the parties agree

that the City must have the unrestricted right to conduct investigations of citizen complaints and

matters of internal security; provided, however, that any investigative interrogation of any employee

covered by this Agreement relative to a citizen complaint and or a matter of internal security shall

be conducted under the following conditions and following the provisions of F.S.S. 112, the Police

A. No employee shall be ordered to submit to any device designed to measure the truth of his/her responses during questioning, provided, however, that there shall be no restriction on the right of any employee to submit to such device on a voluntary basis.

B. In the interest of internal security and fairness to the employee under investigation, the City insofar as is legally permissible, agrees to make no conclusionary public statements concerning the validity of the allegations under investigation until such time as the investigation has been completed. In the event the employee under investigation, or any organization or person representing said employee makes public statement concerning the allegations under investigation, the City shall have the right to respond in any manner it deems appropriate.

In all cases wherein an employee is to be interrogated concerning an alleged violation of Department Rules and Regulations which, if proved, may result in dismissal or in some other disciplinary measure, the employee shall be afforded a reasonable opportunity and facilities to contact and consult privately with an attorney of his/her choosing and with the representative of the FOP, who may be present during all interrogation. The attorney and their FOP representative may be present during the interrogation. When the attorney and/or representative is not immediately available and conditions permit, the interrogation will be postponed for twenty-four (24) hours or to a date mutually agreed upon.

1	D.	In cases where the City chooses to relieve an employee from duty pending an investigation
2		or other administrative determination, the following conditions will prevail:
3		The employee will remain on full salary and allowances and shall not lose any benefits
4		during this period of time.
5		Should disciplinary action result from the investigation, that period of time in which the
6		employee was relieved from duty will be included in disciplinary action. In the event that
7		an employee has been paid, the employee's accumulated leave or compensatory time shall
8		be charged as a set-off.
9	E.	The findings of internal affairs investigations shall be labeled:
10		1. Unfounded – The act or acts complained of did not occur or did not involve APD
11		personnel.
12		2. Not-sustained – Insufficient evidence to clearly prove or disprove the
13		allegation/complaint.
14		3. Sustained – The preponderance of evidence clearly proves the
15		allegation/complaint.
16		4. Exonerated – The act or acts did occur, but were justified, lawful and proper.
17		5. Exonerated due to policy failure – A finding of conclusion that policy, procedure,
18		rule or regulation covering the situation was non-existent or inadequate.
19	F.	Only "Sustained" complaints will be inserted in an officer's personnel file.
20	G.	The charge "conduct unbecoming an officer" can be used provided it is qualified by "in
21		that the officer did (describe the conduct in detail)."
22	H.	The City shall not discharge or discipline any bargaining unit employee without proper
23		cause and due process, except in layoff situations (Article 4 and Article 6).
24	11.2 If the C	City feels there is proper cause for disciplinary action the employee will be notified in writing
25	that he	e/she will be disciplined clearly stating the reasons.

1		A. In the event an employee becomes the subject of a formal Departmental or City
2		investigation arising from a complaint or allegation, the Department or the City, whichever
3		is appropriate, shall notify the employee of the complaint unless a criminal investigation is
4		initiated.
5		B. Upon conclusion of the formal investigation the employee will be notified of the
6		disposition of the complaint.
7		Article 12
8		LEGAL BENEFITS
9	12.1	The City will defend employees against any legal actions against them as a result of their actions
10		while acting in the scope of their employment (i.e. in the line of duty), unless such employee acted
11		in bad faith or with malicious purpose or in a manner exhibiting wanton and willful disregard of
12		human rights, safety or property (acting outside legal authority).
13	12.2	The City agrees to indemnify all employees against judgments levied against them as a result of
14		their actions while acting in the scope of their employment, unless the employee acted in bad faith
15		or with malicious purpose or in a manner exhibiting wanton and willful disregard of human rights,
16		safety or property (outside legal authority).
17		Article 13
18		DISCIPLINE, RULES AND REGULATIONS [GW9]
19	13.1	It is agreed that employees covered by this Agreement shall be subject to the City of Alachua
20		Personnel Policies and Procedures and the Alachua Police Department Operations Manual COAPP


