

RESOLUTION 18-14

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AUTHORIZING THE USE OF GENERAL FUND - SPECIAL EXPENSE CONTINGENCY BUDGET IN THE AMOUNT OF \$60,000; TRANSFERRING \$60,000 TO THE ALACHUA POLICE DEPARTMENT BUDGET; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Alachua Commission recognizes the importance of asset maintenance and replacement; and,

WHEREAS, the City of Alachua Commission recognizes that budgetary plans change and needs arise throughout the course of the fiscal year; and,

WHEREAS, City staff has identified the need for additional budget to enable for the replacement of four (4) Alachua Police Department – Patrol vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

- 1. The Finance and Administrative Services Director is directed to transfer sixty thousand dollars (\$60,000) from the General Fund Special Expense Contingency budget to the Alachua Police Department budget as reflected in the budget amendment attached hereto as Exhibit A.
- 2. That this resolution shall take effect immediately upon its adoption.
