counties’ elected officials to provide help when possible.

“At the national, and even the state level, politics is so party-driven, but at the local level it's people-driven,” he said.

The United Way report, which reviewed statistics from 2007 to 2015, found that about 46 percent of households in Alachua County don't earn enough to cover basic living expenses. In Marion County, that's true of 47 percent; Putnam, 52 percent; Bradford, 50 percent; Levy, 43

percent, and in Union, 70 percent.

Arreola said he has begun working to find ways to create better economic opportunities for Gainesville residents. He has floated the idea of creating a community job center, run by the city, to provide careers that offer a living wage.

“Many of us now entering the job market for the first time were still young when the housing market crashed and the Great Recession hit,” he said. “We still remember what it looked like. Almost overnight we saw our parents and our families and our friends' families go from being financially secure to struggling to make ends meet.”

Arreola said most

college graduates finish school in debt and are forced to repay their loans, despite not having yet found careers. He also took issue with reduced K-12 funding under Scott’s tenure.

“Tallahassee has to do better,” he said.

Calvin Camps, a retired Gainesville Regional Utilities worker, said more than 3 million people in Florida are still considered “working poor,” which is nothing to celebrate. He took issue with a few bills Scott signed — HB 25 and HB 7055 — which he said deprive teachers, first responders and public employees the right to negotiate for their jobs.

“We need change. I support change,” he said.
