

RESOLUTION 18-17

A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2017-2018 BUDGET FOR THE RECEIPT OF UNANTICIPATED REVENUE; INCREASING THE MILL CREEK SINK CAPITAL PROJECTS FUND TO APPROPRIATE REVENUES AND EXPENSES RELATED TO THE SUWANNEE RIVER WATER MANAGEMENT DISTRICT (SRWMD) MILL CREEK SINK GRANT; ESTABLISHING THE FLORIDA JOB GROWTH GRANT CAPITAL PROJECTS FUND TO APPROPRIATE REVENUES AND EXPENSES RELATED TO THE FLORIDA JOB GROWTH GRANT FUND TRANSPORTATION INFRASTRUCTURE PROJECT AGREEMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, a Memorandum of Agreement (MOA) for Cost Share Assistance with the SRWMD to improve water quality recharging of the Upper Florida Aquifer at the Mill Creek Swallet was executed on April 7, 2017; and;

WHEREAS, the MOA for Cost Share Assistance with the SRWMD was amended on February 12, 2018 to provide for additional project funding from the Florida Department of Environmental Proteection (FDEP); and,

WHEREAS, On February 19, 2018, the Florida Job Growth Grant Fund Transportation Infrastructure Project Agreement with the Florida Department of Transportation (FDOT) and the Florida Department of Economic Opportunity (DEO) for the roadway and utility infrastructure construction of San Felasco Parkway was executed;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:

- 1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2017-2018 Budget by increasing the Mill Creek Sink Capital Projects Fund and appropriating the amount of one million dollars (\$1,000,000) as reflected in the budget amendment attached hereto as Exhibit A.
- 2. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2017-2018 Budget by establishing the Florida Job Growth Grant Capital Projects Fund and appropriating the amount of six million seven hundred fifty-five thousand dollars (\$6,755,000) as reflected in the budget amendment attached hereto as Exhibit A.
- 3. That this resolution shall take effect immediately upon its adoption.
