Ordinance 18-08, Second Reading: Land Development Regulations (LDR) Text Amendment - A request by the City of Alachua to amend, modify, or create the following Sections of the City of Alachua Land Development Regulations (LDRs): 1.4.5; 1.7.7; 2.2.2(C)(3); 2.2.3(E); 2.2.9(A); 2.2.15(B); 2.4.9(G); 2.4.10; 3.6.3(A)(5); 3.6.3(C)(5); 3.6.3(D)(5); 4.1.2; 4.4.2(D)(2); 4.5.6(D)(4); 6.1.3(N); 6.1.4(B)(2)(a) - (d); 6.8.1(B); 6.8.3(A)(1); and 10.2; and amending Tables 4.1-1 and 4.4-1 (Legislative Hearing).

City Attorney Rush read Ordinance 18-08 by title only.

Principal Planner Justin Tabor introduced the item and provided the staff report.

Mayor Coerper asked the commissioners for questions or comments.

There were no comments.

Vice Mayor Brown moved to find the proposed Text Amendments to the City's Land Development Regulations (LDRs) to be consistent with the City of Alachua Comprehensive Plan and in compliance with the City's LDRs and adopt Ordinance 18-08 on second and final reading; seconded by Commissioner Hardacre.

Mayor Coerper opened the floor for comments.

Assistant City Manager Boukari expressed his gratitude to the Planning Department for the hard work and research that went into this ordinance.

V. AGENDA ITEMS

A. Resolution 18-15: Accepting the Comprehensive Annual Financial Report (CAFR) and Management Letter for the Fiscal Year Ended September 30, 2017

City Attorney Rush read Ordinance 18-15 by title only.

Finance and Administrative Services Director Rob Bonetti introduced the item and made recommendations.

Mr. Ron Whitesides of Purvis, Gray & Company presented the audit findings.

Commissioner Wilford asked where the repayments for the water and waste water would be reflected in the electric fund.

Mr. Whitesides gave clarification.

Mayor Coerper asked the commissioners for questions or comments.

Commissioner Wilford stated that he is proud of this report. He asked about affordable housing.

Finance and Administrative Services Director Bonetti stated that the process was started and was never made official. He stated that since this was never legally formed, this would be removed for next year.

Commissioner Wilford asked about the Deferred Retirement Option Program.

Finance and Administrative Services Director Bonetti responded to the question.

Commissioner Wilford asked about how the population growth would affect the grants for which the staff apply.

Finance and Administrative Services Director Bonetti stated that staff is aware of the situation and are keeping up with the requirements.

Commissioner Wilford asked if it was understood that this report would be public record.

Mr. Whitesides stated that the wording was not intended to imply that the document wouldn't be public record.

Assistant City Manager Boukari congratulated Finance and Administrative Services Director Bonetti and his staff for the excellent report and thanked him for all of the work put into the audit.

Mayor Coerper voiced his admiration for Finance Department and Finance and Administrative Services Director Bonetti in particular.

City Manager Traci Gresham congratulated Finance and Administrative Services Director Bonetti and his team for a job well done.

Mr. Whitesides thanked the Commission.

Finance and Administrative Services Director Bonetti commented on the support he has received from Purvis, Gray & Company.

Commissioner Hardacre moved to adopt Resolution 18-15 Accepting the Comprehensive Annual Financial Report and Management Letter for the Fiscal Year ended September 30, 2017; seconded by Commissioner Wilford.

He announced the Third Thursday on Main would be on April 19, 2018. He stated that this would be an Art Walk with juried artists and live music. He thanked Ms. Foxworth for bringing her concerns to the Commission. He stated that he would like to meet with her to discuss her situation further.

City Attorney Rush addressed Ms. Foxworths statements and provided clarification.
