Financial Report for May 2018

Revenues and expenditures are within budget for the first eight months of the fiscal year. The financial condition of the Council remains sound.

Transportation Disadvantaged Local Program Administrative Support Grant Resolutions - FY 18/19

The NCFRPC is the designated official planning agency for Bradford, Columbia, Dixie, Gilchrist, Hamilton, Lafayette, Levy, Madison, Suwannee, and Union Counties. As such, these resolutions authorize the Chair to sign said grant resolutions with the Community Transportation Coordinators in the region.

Transportation Disadvantaged Local Coordinating Board Appointments

According to **Rule 41.2.012, Florida Administrative Code**, NCFRPC, serving as the designated official planning agency, is responsible for appointing members to the Transportation Disadvantaged Local Coordinating Boards. The following individuals were recommended for appointment: (1) Bonnie Burgess, Voting Florida Department of Education Representative, Lafayette County, and (2) Hannah Engle, Voting Florida Department of Education Representative, Madison County.

Guest Speaker - Jerry Parrish, Chief Economist and Director of Research, Florida Chamber Foundation

Mr. Parrish provided an overview regarding the activities of the Florida Chamber Foundation including the "Six Pillars (See Executive Director Report)" and highlighted the following information:

- Income migration into the state is \$879,000 per hour.
- Florida, if viewed as a country, is the 17th largest economy in the world.
- In the past two years, the Foundation conducted "Year 2030" town hall meetings in each of the state's 67 counties:

Citizens Engaged - 10,000+
Miles Traveled - 20,000+
Recorded Hours of Conversation about Florida's Future - 150
Business, Chambers, and Foundation Partners - 200+

- Florida ranked 18th in the country with more jobs in 2016 than in 2007.
- A total of 180,200 jobs were created in Florida in the past 12 months:

Professional and Business Services - 39,200. Leisure and Hospitality - 37,200. Construction - 31,300. Education and Health Services - 24,500. Financial Activities - 17,200. Trade, Transportation, and Utilities - 15,400. Manufacturing - 12,100. Government - 1,200.

Chair Report

Resolution of Appreciation for Mayor Garth "Sonny" Nobles

Mayor Nobles also received a gift for his faithful service for such a long period of time on the Council having served as the council's Chair, and in other officer positions, on several occasions. Motion was approved *unanimously*.

Ratification of Committee Appointments for 2018-2019

Mayor Davis recommended that the committee appointments be ratified for 2018-2019. Emphasis on appointment to committees is placed on a broad geographic representation throughout the region and council attendance record by each appointee. Motion was approved *unanimously*.

Executive Committee Report - None.

Clearinghouse Committee Report

Commissioner Adams, Lafayette County, Chair, presented the report and stated that the Committee recommends the following "Comprehensive Plan Adopted and Draft Amendments" be approved: City of Archer adopted amendment, City of Chiefland two draft amendments, Dixie County draft amendment, City of Gainesville adopted amendment, and Union County adopted amendment. Motion was approved unanimously.

Regional Planning Committee Report

Commissioner Warren, City of Gainesville, Chair, stated that the Committee recommends approval of the proposed "Evaluation and Appraisal Report (EAR)-based" amendments to the North Central Florida Strategic Regional Policy Plan. At its December 14, 2017, meeting, the Council voted to schedule public workshops pursuant to Chapter 120, Florida Statutes, to receive public comment regarding proposed amendments to the subject plan. Public workshops were held by Council staff on March 13, 2018, in Bronson, and in Gainesville on March 15, 2018.

Comments were received from the Alachua County Growth Management Department and the Levy County Planner which identified editorial changes. In addition, the Alachua County Growth Management Department recommended that additional text be added to the "Affordable Housing Element Conditions and Trends Statement." The Committee recommends these editorial changes and additional text items be added to the EAR-based amendments to the subject plan. The Committee also recommends that local government-owned conservation and recreation properties either 100 acres in size or located adjacent to an existing "National Resource of Significance" in Levy and Suwannee Counties be added to the subject plan as "Planning and Management Area Natural Resources of Regional Significance" to the proposed EAR-abased amendments.

In addition, the Committee reviewed a request from the Alachua County Board of County Commissioners that all lands classified as "Priority 3" within the "Florida Ecological Greenways Map of Regionally Significance Natural Resources," or at least all such lands within Alachua County be added. At its March 22, 2018, meeting the Committee agreed to add all "Priority 3" lands in Alachua County. At its next meeting on May 24, 2018, the Committee voted to reconsider its action concerning this matter. At this meeting, the Council's attorney advised the Committee that pursuant to *Chapter 186, Florida Statutes* and *Rule 27-E5, Florida Administrative Code*, which govern strategic regional policy plans, the Council must be consistent throughout the region in the identification of "Regional Ecological Greenways as a Natural Resource of Regional Significance." He recommended that the Council either include all lands within the region identified as "Priority 3" or only all lands identified as "Priority 1 and 2." Based on the advice of the Council's attorney, the Committee voted to recommend that the "Map" include only lands within the region as "Priority 1 and 2" in the subject plan.

Finally, the Committee recommended that the Council authorize advertising a public hearing pursuant to *Chapter 120.*Florida Statues, regarding the adoption of the proposed EAR-based amendments to the regional plan as recommended by the Committee. After a lengthy discussion regarding "Greenway Maps," the Committee made a recommendation to authorize advertising a public hearing to adopt the proposed "North Central Florida Strategic Regional Policy Plan" which was approved with Commissioner Meeks, Levy County Board of County Commissioners, dissenting.

Ben Glass, Suwannee River Water Management District (SRWMD) - Mr. Glass stated that a public hearing will be held on July 5, 2018, at 6:00 p.m., at the District's offices in Live Oak, to receive citizen input regarding a "Water Supply Assessment" through 2035. He stated that this type of process is required every five years.

Executive Director Report

Mr. Koons briefed the council on the following items:

Florida Regional Councils Association (FRCA) Monthly Activity Report

FRCA is the statewide organization which is comprised of ten regional planning councils. The mission of the Association is to strengthen Florida's regional planning councils and its partners with government and the business community to enhance regional economic prosperity and improve the consistency and quality of regional planning councils to ensure they add value to state, regional, and local initiatives. Denise Imbler, FRCA Statewide Coordinator, advises and supports NCFRPC in fulfilling its mission.

During May, the Association: (1) organized and distributed the April 2018 FRCA newsletter, *FRCA Forward*, (2) continued to update the FRCA Facebook page, (3) continued working with the Florida Association of Counties regarding the maintenance and enhancement of the FRCA website and newsletter, (4) continued updating and maintaining the "email listserv" for the more than 2,500 individuals who receive *FRCA Forward*, (5) participated in the following activities - (a) Florida Transportation Plan Implementation meeting, (b) resiliency forum which was hosted by the Florida Department of Environmental Protection, (c) coordination meeting with the Florida Department of Environmental Protection, Florida Department of Transportation, and Greenways and Trails Foundation, (d) coastal meeting which was hosted by the Florida Department of Environmental Protection, (e) rural economic development initiative meeting, and (f) Florida Economic Development Council Annual Conference, (6) promoted the "Disaster Supplemental Notice of Funding Opportunity Webinar" which was hosted by the Economic Development Association, (7) participated in the May Executive Directors Advisory Council (EDAC) conference call meeting, and (8) coordinated FRCA participation with the following upcoming annual conferences - (a) National Association of Regional Councils, (b) Florida Association of Counties, (c) Florida League of Cities, and (d) Florida Chapter of the American Planning Association, and (8) distributed grant opportunities and information of interest from local, state and national organizations.

Florida Chamber Foundation Scorecard

Mr. Koons reminded council members that the Florida Chamber Foundation developed the Florida Scorecard to provide state leaders with the metrics needed as a tool to secure Florida's future. In performing this task, the Florida Chamber's primary objective is to develop a 20-year statewide strategic plan which requires an ongoing commitment to measuring the state's current status toward accomplishing the stated goals of the "Six Pillars" which were established to measure trends and progress. The "Six Pillars" incorporate the strategic thinking of a diverse range of stakeholders including the Century Commission for a Sustainable Future, Florida Council of 100, Enterprise Florida, Florida State University, Workforce Florida, 1000 Friends of Florida, and others. The "Six Pillars" are:

- > Talent Supply and Education.
- Innovation and Economic Development.
- Infrastructure and Growth Leadership.
- Business Climate and Competiveness.
- Civic and Government Systems.
- Quality of Life and Places.

Alligator Warrior Festival

This festival is organized by Alligator Festival of Lake City Florida, Inc., which is a volunteer nonprofit public charity. Several members from this group were in attendance. This group is dedicated to teaching and celebrating local history. The festival is held annually in October to commemorate the years between 1800 and 1859, when Lake City was still known as Alligator, Florida, and to celebrate the memory of its most famous resident, Alligator Warrior, who was the Seminole Commander. In addition, the festival includes a reenactment of the 1836 Battle of San Felasco Hammock. It is also held to celebrate Native American and immigrant American cultures with music and dancing, living history camps, demonstrations of historic skills, traders, craftspeople, and food vendors. This year's festival will be held on October 19, 2018, through October 21, 2018, at O'Leno State Park, in High Springs.

Financial Disclosure Report Filing

He indicated that the financial disclosure form filed by county and city commissioners for their elected offices fulfills this requirement for membership on the Council.
