#### VII. COMMENTS FROM CITY MANAGER AND CITY ATTORNEY

City Manager Boukari stated that the Strategic Planning Retreat would be June 26, 2018 at the Swick House, and invited the citizens to attend. He reminded the citizens that the July 4<sup>th</sup> celebration would be on Wednesday, July 4, 2018. He requested that the citizens arrive early to ease traffic concerns. He mentioned that the Welch Park renovations have begun. He stated that part of the proposed budget would be to renovate Maude Lewis Park and Gerald Criswell Park in the coming year. He stated that he received word from Michele Lieberman of Alachua County regarding the proposed fairgrounds, along with a request for possible fairgrounds sites from the cities. He asked if the commission would like for him to look into parcels that would qualify.

City Attorney Rush thanked everyone for their condolences as she has recently lost her mother.

#### VIII.COMMISSION COMMENTS/DISCUSSION

Commissioner Miller thanked those in attendance for their input. She thanked Pastor Grigger for the invocation. She stated that she went to Welch Park, and was impressed with the progress. She stated that she attended Third Thursday on Main, and enjoyed the event. She stated that she attended the Kiwanis Santa Fe Cookout, and that Officer Charles Lee was great with the kids that day. She congratulated Sandy Burgess for receiving the Alachua Lion of the Year Award from the Lion's Club. She asked City Manager Boukari if properties for the Fairground are suggested, does this imply a commitment.

City Manager Boukari stated that this part of the process was only conceptional.

City Attorney Rush provided more to the explanation.

Commissioner Wilford stated that he attended the Suwannee River Water Management District meeting. He said that he visited with the kids at the Summer Adventure Camp at Legacy Park. He stated that Turkey Creek is trying to figure out why there is such a problem with flooding.

City Manager Boukari stated that the staff informally met with the Suwannee River Water Management District to discuss the Turkey Creek flooding problem.

Vice Mayor Hardacre stated that he attended the Suwannee River Water Management District meeting, and that it was good to see Virginia Johns as the new Chair.

Mayor Coerper invited everyone to go look at the progress of Welch Park. He stated that the Hitchcock's development is looking well. He stated that he went to the meeting at the County for the Fire Rescue and Emergency Services budget talks. He stated that he was pleased with the support from the County.
