WWTF will double capacity by 2020

and Certified Contractor Greg Lang addressed commissioners to review the high points of an agreement between the two entities to begin the expansion process.

"The City's WWTF is currently rated for 240,000 gallons per day," said Lang. "The city is at 75-80 percent of capacity, which is the time to consider designing implementing expansion of the facility," he said. The expanded system will double capacity to 480,000 gallons per day at a cost of \$3 million. Mittauer's agreement is

broken up into two phases; the first of which is design & permitting. "The cost to complete that phase will be \$290,000," said Lang, "which would be offset by the Wastewater Impact Fees the City has been collecting." Lang added there is a "shelf-life" to these fees. "They must be spent or returned to the customer by seven years if they are not used by the City," he said.

The second phase of the project is the construction phase. "We have spoken with the Water Management District and they seem in favor of funding this type of project with springs funding," he said. The fact that the City is taking septic tanks offline and hooking them into the WWTF, in addition to the city's recent growth have made it a desirable project for them

Lang pointed out that there would be an additional \$270,000 is services due during construction. "This is a two-year process," he said. "It should be completed by 2020."


Following questions from commissioners, the Engineering Services Agreement with Mittauer & Associates was approved and signed by High Springs Mayor Scott Jamison.







IMPORTANT INFORMATION REGARDING POSTED NOTICE SIGNS

Pursuant to Section 2.2.9(D) of the City's Land Development Regulations, posted notice signs must be placed on the land that is the subject of the application, along each street which is adjacent to or runs through the land in a manner that makes them clearly visible. Signs shall be posted at intervals of not more than 400 feet when the land subject to the application has less than 1,500 feet of road frontage. When the land subject to the application has 1,500 feet or more of road frontage, signs shall be posted at intervals of not more than 1,320 feet.

Signs shall be inspected by the City subsequent to their posting. The applicant shall be responsible for ensuring that the posted notice is maintained on the land subject to the application until the completion of the final public hearing on the application.

Signs must be removed by the applicant and returned to the City within ten days after the final decision on the application.




