because that did help the economy," she says in the recording.

Yaegar-Eckdahl is the general manager of Hampton Inn by Hampton-Gainesville off Archer Road. She could not be reached for comment.

Estimated costs for law enforcement, the city and county neared \$800,000. University of Florida officials have been reluctant to disclose how much was spent on the event, despite requests. The weeks

leading up to the event were filled with grave concern from government and law enforcement officials who feared outbreaks of violence.

Thousands of protesters and media members flocked to the university the day of the event, as well. After the event, three men were accused of being involved in shooting at anti-Spencer protesters.

Gainesville Mayor Lauren Poe said Tuesday he was unaware of the gaffe and that the site was intended to make people aware of the volunteer opportunities in the community.

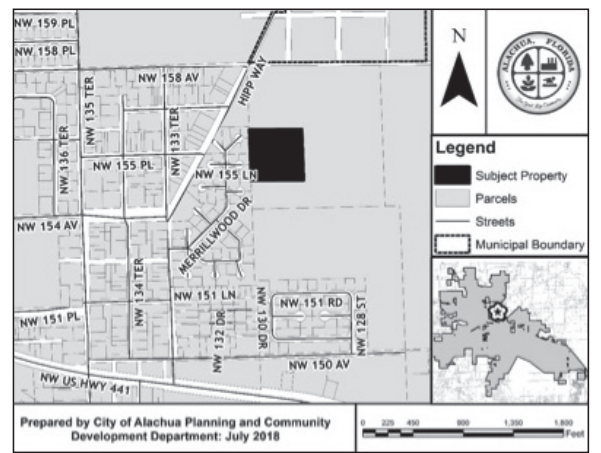

goals include advocating for ballot initiatives like the School Board of Alachua County Infrastructure Sales Tax, which calls for a half-cent, 12-year sales tax to improve school facilities, and the GRU Governance referendum to establish a local governing body for Gainesville Regional Utilities — which hasn't come without controversy.

The City of Gainesville canceled its six chamber memberships in July after it, along with at least some of 106 organizations, accidentally paid chamber invoices that included a \$50 donation for the chamber's PAC, Gainesville Regional Business PC.

In recent years, the PAC has funded campaigns for political candidates and local ballot initiatives, including the GRU referendum the city commission made clear it opposed.

The city had been a chamber member for 30 years.

Mayor Lauren Poe said he hopes the city can later rejoin the chamber, if it changes its billing process.

Kevin Monroe, chairman of the Gainesville Area Chamber of Commerce Board of Directors, said the board hopes to name an interim president before Davenport's departure.

Davenport starts her new role in September.

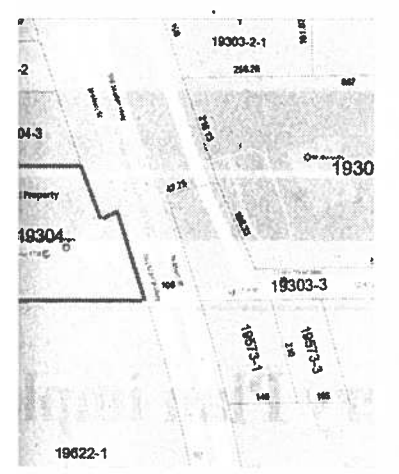

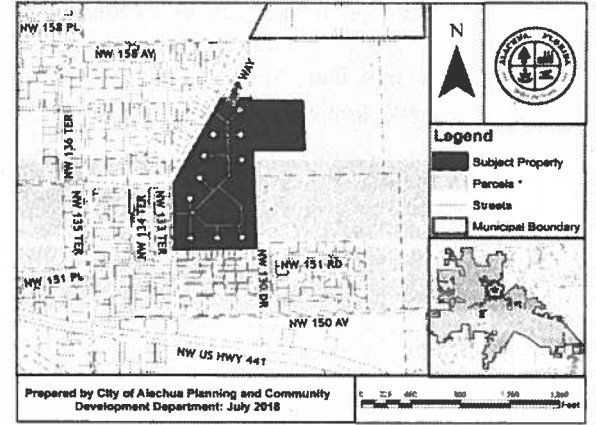

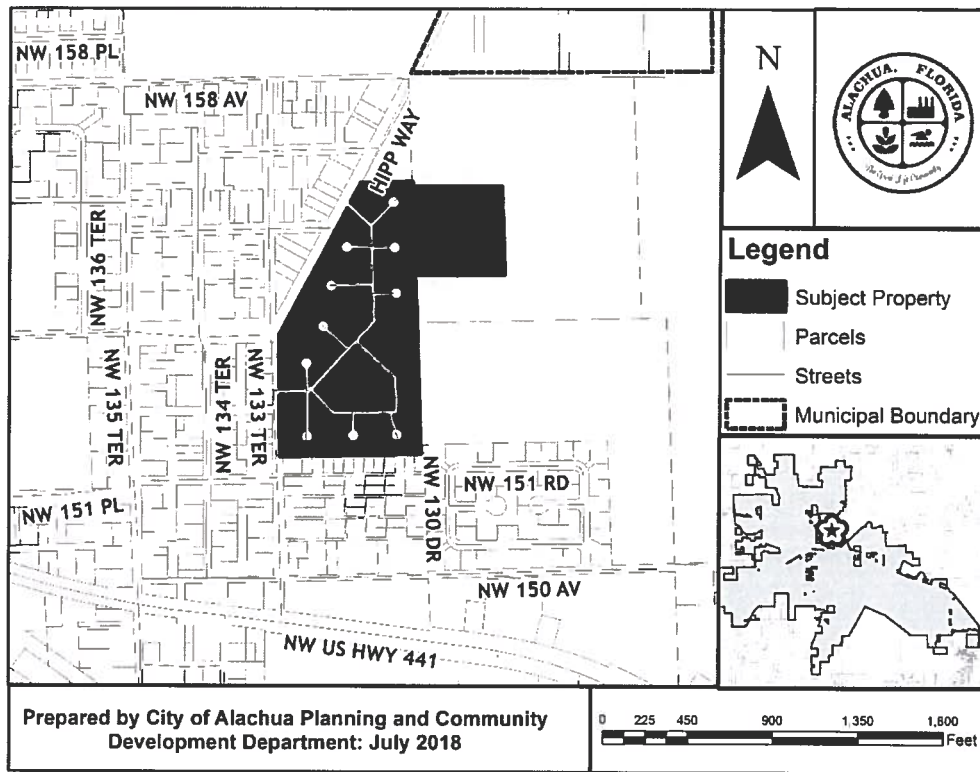
