This agreement is entered into between the City of Alachua (The City”) and the Gator Lodge 67, Fraternal Order of Police, Inc. (“FOP” or “the Union”). The “Police Department” referenced in this Agreement is the Alachua Police Department; hereinafter APD, of the City of Alachua, Florida.

It is the intent and purpose of the City and the FOP to set forth herein their entire agreement concerning wages, hours, and other terms and conditions of employment. There shall be no individual arrangement contrary to the terms of this Agreement.

The words “employee” and “member” are used interchangeably throughout this Agreement. These words are synonymous and refer to employees of the City of Alachua Police Department who are members of the bargaining unit covered by this Agreement.

This Agreement is primarily intended to promote the interests of the citizens of Alachua and the public in general and having at all times available to them services on the most efficient and economical basis practically achievable. The City, the FOP, and each member of the bargaining unit agree to use their best efforts to serve the citizens of the City and the public in general, to see that the public is served efficiently and with dedication to its interests, to assure that the services of the City are provided without interruption and with the highest standards of proper public performance.

It is contemplated that this Agreement will serve the public interest by maximizing the efficiency and productivity of employees of the Alachua Police Department by insuring that members of the bargaining unit will at all times be responsive to and make every reasonable effort to carry forward the City’s legitimate activities and functions with promptness and dispatch, and will accept and execute promptly all instructions and orders given to them; and by defining the City’s obligations to the FOP and members of the bargaining unit, and the FOP and members of the bargaining unit’s obligations to the City, thus avoiding disputes; and to provide a procedure for the resolution of claims that this Agreement has been violated by either party, without any interruption of, or other interference with, the operation of the Police Department.

1 “Days” in this Agreement means working days during a pay period.

4 **RECOGNITION**

5 1.1. The City hereby recognizes the Gator Lodge 67, Fraternal Order of Police, Inc., hereafter referred
6 to as the FOP to be the exclusive bargaining representative for all matters affecting wages, hours,
7 and working conditions for those employees in the unit certified by the Public Employees Relations
8 Commission. **Certification Number 1791**

9 **Included: All employees of the City of Alachua Police Department in the classification**
10 **of communications operator, patrolman, and sergeant.**

11 **Excluded: All other employees of the City of Alachua Police Department, excluding**
12 **specifically the police chief, the assistant chief, Lieutenants(s) —and the**
13 **communications supervisor, and all other employees of the City of Alachua.**

14 1.2. It is further understood and agreed that the FOP shall designate, in writing, those individuals who
15 may speak on its behalf in any matter between the FOP and the City; however, such matters shall
16 include only those matters with which the FOP has the authority regarding its membership. Any
17 written notice designating any individual to speak on behalf of the FOP shall state the period of
18 time for such designation. Furthermore, a written list of the officers and representatives of the
19 FOP, and those individuals who are authorized to speak on behalf of the FOP, shall be furnished
20 to the Chief of Police immediately upon their designation and the Chief of Police shall be notified,
21 in writing, of any changes of said representative within five (5) days of such change.

22 1.3 Nothing in this Article, however, shall prohibit any member of the bargaining unit from discussing
23 any concern, complaint or suggestion with his or her supervisor, Division Commander or Chief of
24 Police.

26 **GRIEVANCE AND ARBITRATION PROCEDURE**

2.1 In a mutual effort to provide a harmonious working relationship between the parties to this Agreement, it is agreed and understood that there will be procedure for the resolution of grievances between the parties and that such procedure shall cover grievances involving discharge, suspension, demotion, or any other adverse personnel action against a member covered by this Agreement or any other dispute between the City and one or more employees concerning the interpretation or application of, or compliance with the agreement including disputes regarding discipline. The discharge, discipline, demotion, layoff or suspension of probationary/training employees on initial hire or rehire shall not be subject to the grievance procedure of this Agreement.

2.2 Every effort will be made by the parties to settle any grievance as expeditiously as possible. Any grievance not answered by Management within the prescribed time limits shall automatically advance to the next higher step. Should the grieving party fail to observe the time limits as set forth in the steps of this Article, grievance shall be considered conclusively abandoned.

2.3 Grievances shall be presented in the following manner:

Step 1: Employee shall first take up grievance with the immediate supervisor within five (5) working days of the occurrence of the event(s) which gave rise to the grievance or from the date which the employee becomes knowledgeable of the cause of action. If the event which gave rise to the grievance occurred at a time when the employee was on annual leave, sick leave or other compensated leave, the five (5) working day period shall commence running immediately upon the employee's return from such compensated leave. The first step shall be on an informal and oral basis. The FOP representative may be present to represent the employee. The immediate supervisor shall render decision within five (5) working days.

Step 2: Any grievance which cannot be satisfactorily settled with the immediate supervisor shall be reduced in writing by the employee or a FOP representative and shall next be taken up with the Chief of Police through the grievant or the representative of the FOP and the Chief of Police within five (5) working days after completion of Step 1. The Chief of Police shall within five (5) working days after discussion render decision in writing, with a copy to the employee's

2 **Step 3:** Any grievance not satisfactorily settled at Step 2 will be taken up with the City Manager or
3 designee with five (5) days from the date the Chief of Police has rendered decision. The
4 grievance as specified in writing shall be discussed by and between the employee and
5 representative of the FOP and the City Manager within five (5) working days after completion
6 of Step 2. The City Manager shall, within five (5) working days, render a written decision.

7 **Step 4:** Arbitration: In the event a grievance processed through the grievance procedure has not been
8 resolved at Step 3 above, the FOP and/or the grievant may request that the grievance be
9 submitted to arbitration within fifteen (15) working days after the City Manager renders a
10 written decision on the grievance. The arbitrator will be any impartial person mutually agreed
11 upon by and between the parties. If an impartial arbitrator cannot be mutually agreed upon
12 within fifteen (15) days after the grievance is submitted to arbitration, then the parties shall
13 jointly request the Federal Mediation and Conciliation Service to furnish a panel of seven (7)
14 names from which each party shall have the option within five (5) days of receipt by striking
15 three (3) names in alternating fashion, with the grieving party striking first.

16 A. The City and the FOP and/or grievant shall attempt to mutually agree in writing as to the
17 statement of the grievance to be arbitrated prior to the arbitration hearing, and the
18 arbitrator thereafter, shall confine decision to the particular grievance thus specified. In
19 the event the parties fail to agree on the statement of the grievance to be submitted to the
20 arbitrator, the arbitrator will confine consideration and determination to the written
21 statement of the grievance presented in Step 3 of the grievance procedure.

22 B. The arbitrator shall fashion, an appropriate remedy for violations of the provisions
23 contained in this Agreement.

24 C. The arbitrator shall have no authority to change, amend, add to, subtract from, or
25 otherwise alter or supplement this Agreement to any part thereof or amendment thereto.
26 The arbitration hearing shall be conducted in accordance with the Rules of Procedure
27 promulgated by the Federal Mediation and Conciliation Service.

28 D. Each party shall bear the expense of its own witnesses and of its own representatives for

1 purpose of the arbitration hearing. The impartial arbitrator's fee and related expenses and
2 expenses of obtaining a hearing room, if any, shall be equally divided between the parties.
3 Any party desiring a transcript of the hearing shall bear the cost of such transcript unless
4 both parties mutually agree to share said cost.

5 E. Copies of the arbitrator's award shall be furnished to both parties within thirty (30) days
6 of the close of the arbitration hearing. The arbitrator's award shall be final and binding
7 on the parties.

8 F. Where a grievance is general in nature, in that it applies to a number of employees rather
9 than a single employee, or if the grievance is directly between the FOP and the City, such
10 grievance shall be presented by the FOP Representative, in writing, directly to the City
11 Manager, (Step 3) within ten (10) working days of the occurrence of the event(s).

12 G. All above-mentioned time frames may be extended in writing by mutual
13 agreement.

14 **Article 3**

15 **DUES DEDUCTION**

17 3.1 Any member of the Bargaining Unit may have membership dues deducted from wages. Dues shall
18 be deducted once each month and shall thereafter be transmitted to the FOP, accompanied by a list
19 of those employee's names whose dues are included.

20 3.2 The FOP agrees to indemnify, defend and hold the City harmless against any and all claims, suits,
21 orders of judgments brought or issued against the City as a result of any action taken or not taken
22 by the City under the provisions of this Article.

23 **Article 4**

24 **MANAGEMENT RIGHTS**

1 4.1 It is the right of the Employer to determine unilaterally the purpose of each of its constituent
2 agencies, set standards of services to be offered to the public and exercise control and discretion
3 over its organization and operations.

4 4.2 In addition, the FOP recognizes the sole and exclusive rights, powers and authority of the Employer
5 further include, but are not limited to, the following: to direct and manage employees of the City;
6 to hire, promote, transfer, schedule, assign and retain employees, to suspend, demote, discharge or
7 take other disciplinary action against employees for proper cause; to relieve employees from duty
8 because of lack of work, funds, or other legitimate reasons; to maintain the efficiency of its
9 operations including the right to contract and subcontract existing and future work; to determine the
10 duties to be included in job classifications and the numbers, types and ~~grades-ranks~~ of positions or
11 employees assigned to an organizational unit, department or project; to assign overtime and to
12 determine the amount of overtime required, to control and regulate the use of all its equipment and
13 property; to establish and require employees to observe all its rules and regulations, to conduct
14 performance evaluations; and to determine internal security practices. The Employer agrees that,
15 prior to substantial permanent lay-off of FOP bargaining unit members, it will discuss such with the
16 FOP.

17 4.3 If, in the sole discretion of the City Manager/Designee, it is determined that civil emergency
18 conditions exist, including, but not limited to, riots, civil disorders, severe weather conditions (or
19 similar catastrophe), the provisions of this Agreement may be suspended by the City
20 Manager/Designee during the time of the declared emergency, provided that wage rates and
21 monetary fringe benefits shall not be suspended. Should an emergency arise, the FOP shall be
22 advised as soon as possible of the nature of the emergency.

24 **Article 5**

25 **PERSONNEL RECORDS**



26 5.1 Each employee covered by this Agreement shall have the right to inspect his or her official
27 personnel file, provided, however, that such inspection shall take place during working hours at the

1 location where the official personnel file is kept. The employee shall have the right to make
2 duplicate copies of any items contained in his or her official personnel file.

3 5.2 Employees shall have the right to file a written response to any letter of reprimand or to any
4 document which is placed in the employee's official personnel file as a result of supervisory action
5 or citizen complaint. At the employee's request any such written response shall be included in the
6 employee's official personnel file together with the letter of reprimand or other document against
7 which it is directed.

8 5.3 To the extent permitted by law and in order to protect the privacy and promote the safety of
9 individual police officers, the City agrees not to directly or indirectly furnish the news media or the
10 public with any employee's home address, telephone number or photograph.

11 5.4 The FOP agrees not to directly or indirectly furnish the news media or the public with personnel
12 records without the consent of the City and the employee thus insuring the confidentiality of
13 personnel records other than required by law.

14 **Article 6**

15 **SENIORITY**

16 6.1 The City agrees that seniority time in service shall consist of continuous accumulated paid service
17 with the City of Alachua -Police Department. It shall be computed from the date probation is
18 completed in rank or classification of hire. Seniority is defined as time in rank or classification from
19 the date of successful completion of the probation/training period. Members serving in a higher
20 rank or classification shall have seniority over those of lower rank or classification Seniority shall
21 accumulate during leaves of absence due to injury, illness, vacation, or any other leave authorized
22 and approved by the City.

23 6.2 Vacation periods for each calendar year shall be drawn by employees on the basis of seniority in
24 rank.

25 6.3 In the event of a layoff for any reason, employee rank, performance evaluations and classification
26 will be the determining factors s used by the City. In the event that more than one employee has the

1 same performance evaluation, employees will be laid off in the inverse order of their rank and
2 seniority. Any employee to be laid off, who has advanced to present classification from a lower
3 rank or classification, in which he or she held a permanent appointment, shall be given an open
4 position in a lower ~~classification in the same department~~rank or classification. His or her seniority
5 in the lower classification shall be established according to the date of permanent appointment with
6 the Police Department. No new employee shall be hired in any classification until all employees
7 on layoff status in that classification have had an opportunity to return to work. Employees shall
8 be called back from layoff with rank and the performance evaluation being the determining factors.
9 In the event that more than one employee of the same rank and classification has the same
10 performance evaluation, employees will be recalled according to the seniority in ~~the rank or~~
11 classification from which the employee was laid off.

12 6.4 Employees shall be notified of their recall to work by registered letter mailed to their address of
13 record and shall be given fifteen (15) calendar days to return to work. A recalled employee shall
14 notify the employer in writing of the employee's intent to return to work within five (5) calendar
15 days of notice of attempt to deliver the recall letter.

16 6.5 An employee laid off pursuant to this Article, provided the insurance carrier concurs, shall be given
17 the opportunity to continue insurance coverage in existing programs during the layoff provided that
18 the premiums for such insurance programs shall be paid by the employee on a monthly basis in
19 advance of the month due.

20 6.6 Recall will be the current rate of pay for classification and rank but not lower than that of ~~when~~ the
21 employee ~~was~~ when laid off. Upon recall, all credit for seniority shall be restored.

22 In the event of a vacancy in a ~~Department or Division~~ an assignment, ~~and~~ or a promotional vacancy,
23 seniority will be given reasonable consideration, but will not be the determining factor.

24 6.7 Seniority shall also be considered in the selection of any employee to be sent to any type of
25 schooling or training.

7.1 **Leave of Absence Without Pay:**

The decision to grant leave without pay (leave of absence) is a matter of administrative discretion. It shall be incumbent upon the Chief of Police to weigh and determine each case on its own merits. Any leave of absence for a period of thirty (30) days or more must have the approval of the City Manager. Failure of any employee to timely return to duty upon expiration of his/her leave of absence shall constitute the resignation of that employee. Holidays, sick leave, annual leave, seniority and any other benefits based on time spent in the employment of the City shall not accrue during a leave of absence without pay provided, however, that the employee may maintain health insurance coverage by paying the total cost of his/her group insurance premium. Longevity increases, merit increases and any other increases for which an employee may become eligible based on whole, or in part on length of service with the City shall not be credited during any period of leave of absence without pay.

- A. An employee shall return from leave of absence at the same ~~step of his/her salary~~ grade rank and pay as at the time of commencement of leave of absence.
- B. Any employee who is a member of the National Guard or an organized military service unit of the United States will be granted ~~allowed~~ a leave of absence ~~with pay~~ when called to active duty or for training with the armed forces in accordance with State and Federal Law.

7.2 **General**

An employee shall return from any leave of absence at the same rank and pay to the same step of his/her salary grade as at the time of commencement of the leave of absence. Military leave shall be granted in accordance with the provisions of State and Federal Law. All employees entitled to military leave shall give their supervisor an opportunity, within the limits of military regulations, to determine when such leave shall be taken.

1 7.3 **Leave of Absence With Pay**

2 Leave with pay for sufficient cause (including illness if sick leave is unavailable) may be granted to
3 regular employees of the City, by the City Manager, up to and including five (5) consecutive working
4 days in any twelve-month period. More extended periods of leave with pay may not be granted
5 except by express approval of the City Commission. This provision is applicable only if all accrued
6 vacation time is exhausted.

10 **PROBATIONARY /TRAINING PERSONNEL**

13 a probationary/training period of 365 days, which can be extended for up to 6 months at the
14 discretion of the Chief of Police, during which time they shall not be entitled to any seniority rights
15 but during such period shall be subject to all terms and conditions of this Agreement.

16 ~~8-38.2~~ Upon successful completion of said 365 days or such period of extension as provided for in 8.1,
17 new employees shall be shown as regular full time employees and those promoted within the
18 classification of Police Officer or to Sergeant shall accrue seniority in classification or rank from
19 the date of successful completion of the probationary/training period.

8 written reasons for the request, qualifications and other support for transfer to the assignment. All
9 Such requests shall be received by the Chief, as evidenced by proof of sending the email on the City
10 IT System to the Chief, fourteen (14) days before the published assignment date. The Chief of
11 Police, as provided for in Article 4, will consider all such requests and make the final staffing
12 decision and selection from the members of the entire bargaining unit as the Chief determines to be
13 in the best interests of the City.

17 10.1 During a primary, general, or special election, an employee who is a registered voter whose hours of
18 work do not allow sufficient time for voting shall be expected to take advantage of early voting,
19 absentee ballot or other options available to the public.

20 10.2 Employees will be allowed to engage in the full range of political activities guaranteed to all citizens
21 while off duty and not in uniform.

22 **Article 11**

23 **INTERNAL INVESTIGATIONS & OBLIGATIONS TO THE PUBLIC**

24
25 11.1 The parties recognize that the security of the City and its citizens depends to a great extent upon the
26 manner in which the employees covered by this Agreement perform their various duties. Further,

1 the parties recognize that the performance of such duties involves these employees in all manner of
2 contacts and relationships with the public and out of such contact and relationships, questions may
3 arise or complaints may be made concerning the actions of employees covered by this Agreement.
4 Investigation of such questions and complaints must necessarily be conducted by a sworn law
5 enforcement officer whose concern must be the security of the City and preservation of the public
6 interest.

7 In order to maintain the security of the City and protect the interests of its citizens, the parties agree
8 that the City must have the unrestricted right to conduct investigations of citizens' complaints and
9 matters of internal security; provided, however, that any investigative interrogation of any employee
10 covered by this Agreement relative to a citizen's complaint and or a matter of internal security shall
11 be conducted under the following conditions and following the provisions of F.S.S. 112, the Police
12 Officer's Bill of Rights.

13 A. No employee shall be ordered to submit to any device designed to measure the truth of
14 his/her responses during questioning, provided, however, that there shall be no restriction
15 on the right of any employee to submit to such device on a voluntary basis.

16 B. In the interest of internal security and fairness to the employee under investigation, the
17 City insofar as is legally permissible, agrees to make no conclusionary public statements
18 concerning the validity of the allegations under investigation until such time as the
19 investigation has been completed. In the event the employee under investigation, or any
20 organization or person representing said employee makes public statement concerning the
21 allegations under investigation, the City shall have the right to respond in any manner it
22 deems appropriate.

23 C. In all cases wherein an employee is to be interrogated concerning an alleged violation of
24 ~~the~~ Department's Rules and Regulations which, if proved, may result in dismissal or in
25 some other disciplinary measure, ~~he~~the employee shall be afforded a reasonable
26 opportunity and facilities to contact and consult privately with an attorney of his/her
27 choosing and with the representative of the FOP, who may be present during all

1 interrogation. The attorney and their FOP representative may be present during the
2 interrogation. When the attorney and/or representative is not immediately available and
3 conditions permit, the interrogation will be postponed for twenty-four (24) hours or to a
4 date mutually agreed upon.

5 D. In cases where the City chooses to relieve an employee from duty pending an investigation
6 or other administrative determination, the following conditions will prevail:

7 The employee will remain on full salary and allowances and shall not lose any benefits
8 during this period of time.

9 Should disciplinary action result from the investigation, that period of time in which the
10 employee was relieved from duty will be included in disciplinary action. In the event that
11 an employee has been paid, the employee's accumulated leave or compensatory time shall
12 be charged as a set-off.

13 E. The findings of internal affairs investigations shall be labeled:

14 1. Unfounded – The act or acts complained of did not occur or did not involve APD
15 personnel.

16 2. Not-sustained – Insufficient evidence to clearly prove or disprove the
17 allegation/complaint.

18 3. Sustained – The preponderance of evidence clearly proves the
19 allegation/complaint.

20 4. Exonerated – The act or acts did occur, but were justified, lawful and proper.

21 5. Exonerated due to policy failure – A finding of conclusion that policy, procedure,
22 rule or regulation covering the situation was non-existent or inadequate.

23 F. Only "Sustained" complaints will be inserted in an officer's personnel file.

24 G. The charge "conduct unbecoming an officer" can be used provided it is qualified by "in
25 that the officer did (describe the conduct in detail)."

1 H. The City shall not discharge or discipline any bargaining unit employee without proper
2 cause and due process, except in layoff situations (Article 4 and Article 6).

3 11.2 If the City feels there is proper cause for disciplinary action the employee will be notified in writing
4 that he/she will be disciplined clearly stating the reasons, ~~therefore,~~

5 A. In the event an employee becomes the subject of a formal Departmental or City
6 investigation arising from a complaint or allegation, the Department or the City, whichever
7 is appropriate, shall notify the employee of the complaint unless a criminal investigation is
8 initiated.

9 B. Upon conclusion of the formal investigation the employee will be notified of the
10 disposition of the complaint.

11 **Article 12**

12 **LEGAL BENEFITS**

14 12.1 The City will defend employees against any legal actions against them as a result of their actions
15 while acting in the scope of their employment (i.e. in the line of duty), unless such employee acted
16 in bad faith or with malicious purpose or in a manner exhibiting wanton and willful disregard of
17 human rights, safety or property (acting outside legal authority).

18 12.2 The City agrees to indemnify all employees against judgments levied against them as a result of
19 their actions while acting in the scope of their employment, unless the employee acted in bad faith
20 or with malicious purpose or in a manner exhibiting wanton and willful disregard of human rights,
21 safety or property (outside legal authority).

- 13.1 It is agreed that employees covered by this Agreement shall be subject to the City of Alachua Personnel Policies and Procedures and the Alachua Police Department Operations Manual as either one now exists or may be amended. Should there be any conflict between the provisions of the Operations Manual and the City's Personnel Policies and Procedures, the City's Personnel Policies and Procedures shall prevail. This Agreement shall prevail in any conflict with either the Alachua Police Department Operations Manual or the City of Alachua Personnel Policies and Procedures.
- 13.2 Failure of employees to comply with the terms of the City's Personnel Policies and Procedures and the Police Department Operations Manual may result in the imposition of disciplinary action pursuant to the provisions of these above cited Rules.
- 13.3 It is the understanding and the intention of the parties that any disciplinary action taken in the case of an employee in this bargaining unit shall be subject to the grievance procedure as provided in Article 2 of this Agreement.
- 13.4 New or revised rules implemented within the Police Department Operations Manual and any changes in the City of Alachua Personnel Policies and Procedures, shall be posted on the FOP bulletin board at least 30 days prior to the effective date if the proposed changes in Policy and Procedures will impact wages, hours or terms and conditions of employment If the FOP disagrees with a new Police Department rule or City Personnel Policies and Procedures, it shall make a written request for a meeting with the designated city bargaining representative to attempt to reach a mutual agreement. The FOP request shall be shall be delivered to the designated city bargaining representative and the meeting shall be held prior to the proposed effective date of such rule. The 30 day posting requirement may be waived by mutual agreement between the local FOP Representative and the City Representative.
- 13.5 A copy of the City Personnel Policies and Procedures is issued to each member and is available on COA Intranet.

TEMPORARY ASSIGNMENT TO A HIGHER CLASSIFICATION

Article 15

TRAINING

15.1 Where the City requires any employee to attend supervisory training and/or training in specialized techniques, the City will make every reasonable effort to facilitate the employee attending such training during normal working hours. In the event the City is unable to schedule the employee to attend such training during normal working hours, the employee shall be required to attend such training during off-duty hours. However, the time spent by the employee in such training during off-duty hours shall be compensated in accordance with Hours of Work and Overtime.

15.2 All sworn officers will be required to train and qualify with their service weapon on a semi-annual basis. The training will be conducted by a certified firearms instructor. All ammunition and safety equipment will be furnished by the City. Any employee required to attend such training during off-duty hours will be compensated in accordance with Hours of Work and Overtime. An employee will be required to post a score of at least seventy-five (75%) to qualify. Any employee posting a score of ninety-two percent (92%) or better, two consecutive semiannual times, will receive a bonus of one day of paid leave, not charged against any other leave time, to be taken by employee at any time, with approval of the supervisor.

15.3 Transportation to the pistol range or transportation to any required and scheduled training shall be provided by the Police Department. In the event such transportation is not available, the employee shall be entitled to applicable travel time and mileage allowance, at the current rate established by the I.R.S.

1 15.4 Current Florida State Statutes are on file at the Police Department and online for use by all

WORKERS COMPENSATION BENEFITS

18.1 Workers Compensation provides medical and hospitalization expense benefits as well as partial payments in lieu of salary for workers injured on the job per applicable State of Florida Statute 440. 100% compensation will be paid by the City for loss time up to two (2) weeks. After that time payment will be made directly from workers compensation at 66% of total gross. Supplement pay of 34% can be acquired by utilizing sick leave and vacation time. Health insurance premiums will have to be paid by the employee after six (6) months on Workers Compensation Rules. Vacation and sick leave accrual will discontinue after six (6) months on Workers Compensation Rules.

EQUIPMENT

20.1 The City will provide, at no cost to each employee, all uniforms required by the Police Department including a flashlight and batteries, bulletproof vest with a current warranty and a portable radio.

A The City will provide each sworn employee with an annual stipend of \$100 (one hundred dollars) for the purchase of footwear that meets the guidelines according to policy.

B The \$100.00 will be paid annually in a lump sum in the first pay period beginning in October 2018.

4 20.2 Any employee who shall sustain any breakage, loss or damage to uniform or personal equipment in
5 the line of duty shall have it replaced at no cost to the employee.

6 20.3 All officers will inspect their vehicle before going on the street. If the officer finds any fault in the
7 vehicle which might be considered a safety hazard, the officer shall inform the shift supervisor. The
8 vehicle will not be returned to duty until all safety hazards are eliminated. When it has been proven
9 that damage is due to operator negligence, the officer shall be subject to disciplinary action.

10 20.4 Upon completion of the FTO program regular full time sworn officers will be assigned a (take
11 home) vehicle. Officers assigned take home vehicles shall be allowed to drive their assigned



Article 21

HOURS OF WORK AND OVERTIME

23 21.1 The following provisions shall govern hours of work and overtime:

24 A. Eighty (80) hours shall constitute a regular fourteen (14) day work period for all sworn
25 Police Officers including Sergeants, no matter the regular duty assignment. Forty (40)
26 hours shall constitute a regular seven (7) day work period for all other employees covered

- 1 under this agreement. For the purpose of this Agreement, authorized compensated leave
2 shall mean any leave compensated by the City.
- 3 B. Hours worked in excess of a regular forty (40) or regular eighty (80) hour work period
4 shall be compensated at the rate of time and one-half of the employee's regular straight
5 time rate. Compensation will be paid or as compensatory leave if requested by employee
6 and approved by the City.
- 7 C. If an employee covered by this Agreement is called out to work at a time outside normal
8 working hours, the employee shall receive a minimum of three (3) hours pay at the rate
9 of time and one-half regular straight time. Call out time that falls either within one hour
10 (1) hour before or within one (1) hour after the regular workday is considered an extension
11 of the work day and is included in the total hours worked on that day.
- 12 D. The aforementioned minimum call out compensation shall apply to required off-duty
13 appearances as subpoenaed witness to attend any court, deposition, or other legal matters
14 on pending criminal civil, or traffic cases where the employee is involved in official police
15 capacity. Any witness fees, excluding salary or overtime pay, or any other related fees in
16 connection with the appearance before any court or for the purpose of taking depositions
17 shall be donated by the employee to the APD Explorer Special Revenue Account.
- 18 E. No supervisor or official shall take action to cause the non-payment of time and one-half
19 in circumstances wherein the member covered by this Agreement has performed work
20 which entitles the member to payment of time and one-half.
- 21 F. Work schedules will not be changed or altered to avoid the payment of overtime.
- 22 G. When an employee is put on a standby status for any reason, he/she shall receive overtime
23 at the established rate of time and one-half regular rate of pay. Standby status is defined
24 as when the personal activities of an employee are restricted to such a degree as not to
25 allow any movement from a designated area or location.

1 H. An employee performing any authorized extra-duty assignment shall be entitled to the
2 same rights, privileges, and benefits as if working regular duty hours. Compensation for
3 extra-duty assignments will be at the established rate.

4 I. Hours worked by an employee in an extra-duty status as outlined in APD Extra Duty
5 Policy and Procedures must be paid regardless of work week provisions set forth in Article
6 21.A.

7 J. The City has the authority to establish shifts and to use any method in establishing a shift
8 as well as change, increase, decrease, initiate, restrict and cancel a shift in order to meet
9 the needs of the department and to provide superior service to the community. However,
10 the Department shall make a reasonable effort to provide two (2) weeks prior written
11 notice to the affected employees.

14 22.1 Every regular full time employee shall receive a paid vacation accrued at the following rates for
15 each full calendar year of service.



8 22.3 An employee request that accrued annual time be cashed-in in lieu of leave taken, may be approved
9 or rejected at the option and discretion of the City.

10 22.4 Accumulated annual leave not used during the calendar year in which it is eligible to be taken may
11 be carried over or accumulated to the following calendar year. However, an employee cannot carry
12 over more than 240 hours of annual leave beyond each calendar year ending December 31. It is the
13 responsibility of the bargaining unit member to be aware of accrued and accruing annual leave and

2 time. Any full time sworn officer working a 12 hour work day schedule for the entire calendar year

1 practical exercise, role playing and an oral board. An employee will have to obtain a score of at
2 least 70% on the written exam to continue to the next stage of the process. The written test will
3 consists of 100 multiple choice questions and the score is valid for two full years from the date of
4 taking. However, if an officer elects to retake the written test when it is offered, only the more
5 recent test score will be valid. The practice exercise will consist of presenting the officer with a
6 simulated event and then requiring the officer to complete the required report(s) in order to evaluate
7 the candidate's perception, knowledge and report writing skills. The third phase involves the
8 candidate in a role playing exercise. The exercise is designed to evaluate the candidate's
9 knowledge, judgment, composure, interpersonal skills, leadership and decision making. The
10 practice exercise and role playing phase may be combined. The final phase consists of an oral board
11 made up of the three (Sergeants or lieutenants or any combination) from law enforcement agencies
12 in the state. The City will assemble and select the board and bear any associated costs during the
13 oral board. Candidates will be asked to respond to questions concerning situations a Sergeant with
14 APD would be expected to encounter.

15 Each phase (1-4) will be graded separately and weighted at 25 percent of the total score of 100 (25
16 points each).

17 All candidates will be given the same written exam (phase I), and presented with the same practical
18 exercise (phase II) and role playing scenario (phase III). The oral board will be unscripted (phase
19 IV).

20 ~~30.630.5~~ The FOP may have one (1) proctor present during any part of the examination process
21 (written or oral). The proctor shall act as an observer and will not interfere with the examination.

22 ~~30.730.6~~ The Chief of Police will be able to pick from the top three employees on the promotional list
23 when determining who is to be promoted. The promotional list shall be valid for 24 months from
24 the date of its inception. Should the City offer a new test before the expiration of the promotional
25 list, the officers on the current list shall have the option to re-test. The rankings shall be from
26 highest score to lowest and will incorporate officers from any and all current testing cycles.
27 However, officers will be deleted from the promotion list when their 24 month eligibility expires.

1 As officers are removed, those employees remaining on or added to the promotional list from a
2 new testing cycle will be ranked from the highest score to the lowest.
