#### IV. PUBLIC HEARINGS AND ORDINANCES

A. Ordinance 19-03, Second Reading; Site-Specific Amendment to the Official Zoning Atlas (Rezoning): A request by Wallace Cain, property owner, to amend the Official Zoning Atlas from Community Commercial (CC) to Residential Single Family – 3 (RSF-3) on a ±20.0 acre subject property, located at 17002 NW County Road 241. Consisting of a portion of Tax Parcel Number 03067-005-000 (Quasi-Judicial Hearing).

#### City Attorney Marian Rush read Ordinance 19-03 by title only.

B. Ordinance 19-04, First Reading; Communications Facilities in Public Rights-of-Way

#### City Attorney Rush read Ordinance 19-04 by title only.

Public Services Director Rodolfo Valladares introduced the item and provided the staff report.

City Attorney Rush recommended adding to the recommendation the ability for Public Services to draft an application consistent with the ordinance.

B. Construction Administration Services for RFB 2018-03 Legacy Park Phase 2A Site/Civil & Landscape

Commissioner Brown moved to 1) Accept the Proposal from Causseaux, Hewett & Walpole for Construction Phase Services for Legacy Park Phase 2A - Site/Civil & Landscape in the amount of \$68,500.00 2) Authorize the City Manager to issue a Purchase Order in the amount of \$68,500.00 to Causseaux, Hewett & Walpole for Construction Phase Services for Legacy Park Phase 2A - Site/Civil & Landscape; seconded by Commissioner Miller.

C. Correspondence to Alachua County Regarding Tobacco Related Ordinance

City Manager Boukari introduced the item and made the presentation.

City Attorney Rush stated as the ordinance stands, it could be viewed as an unfunded mandate.

Mayor Coerper asked the commissioners for questions or comments.

Commissioner Wilford stated the Commission should request that this be an opt-in ordinance.

Commissioner Miller stated she was concerned about the process of opting out.

City Manger Boukari stated he would look into the process, but that it may be done by resolution.

Mayor Coerper suggested the Commission opt-out via resolution upon the passage of the county ordinance, research the issue, and then opt-in, should the Commission determine that this is the best course for the City.

City Manger Boukari stated while the Commission could do just that, it puts the Commission in a position of taking action on an item without all research being conducted.

<u>Vice Mayor Hardacre moved to provide direction to the City Manager on the issuance of correspondence to Alachua County as it relates to the proposed tobacco related ordinance; seconded by Commissioner Brown.</u>

Mayor Coerper opened the floor for comments.
