orange, and fulvous red. Today, we have colors ranging from near-whites, pastels, yellows, oranges, pinks, vivid reds, crimson, purple, nearly true-blue and fabulous blends."

The material states that many people are familiar with only the common yellow or orange daylilies, which are often seen along roadsides. These daylilies are cultivated forms of the wild types that have

"escaped" and are growing as if they are wild.

"All modern daylilies have been developed through a complicated history of hybridization among these and other wild types," the material notes.

Sally Doggett, of McIntosh, is secretary of the Ocala Area Daylily Society, of which she has been a member for three years. She has lived in Florida for about nine years and has grown daylilies both in Florida and Ohio.

Doggett said that she has participated in regional

and national meetings and that hosting the fall regional meeting was a challenge for such a small group, but that everything was going well.

"It is a fun group that has a good time learning about something we are all interested in," she said.

"This is exciting because you get to meet and learn from others in different parts of the state," she said of the Saturday event.

Barbara Wachter, of Belleview, became involved with the Ocala Area Daylily Society the first year it formed, in

2015. She said she first saw daylilies growing in North Carolina and was hooked.

"I just grow them because I love the flower, the yard and gardening," she said, adding that she also likes to meet others interested in daylilies and learn more about them.

The Ocala Area Daylily Society meets at 2 p.m. the fourth Sunday from January-May and September-December at the Marion County Public Library Headquarters, 2720 E. Silver Springs Blvd., Ocala. To learn more, call 591-3120.

market value of the home, making them affordable for people who earn 50 to 80 percent of the area's median income, Davis said.

"That means someone making \$20,000 to \$30,000 a year will be able to make mortgage payments without it being a burden to them," Reynolds said.

Buying homes through CLTs are a pathway to economic stability and much better than renting, in most cases, Reynolds said.

"They allow families to use more of their income

for food and other necessities," Reynolds said. "CLTs provide a stepping stone for building wealth."

Reynolds acknowledged that, arguably, the most significant stigma with the program is that the homeowner doesn't own the land.

The CLT maintains ownership of the land and buyers typically lease the land for 99 years, and if they choose to sell the home, they can receive a percentage of the resale value of the home, which is 25 percent in Hannibal Square, Reynolds said.

Also, CLTs serve as an intermediary between home buyers, mortgage holders and local government, Reynolds said.

New Communities Inc. was the first organization to use the term "community land trust" in the United States. It was founded in 1969 near Albany, Georgia, by leaders of the civil rights movement with the purpose of helping black farmers in the rural South gain access to farmland and to work it with security, according to Maryland's Affordable Housing Land Trust Act.

One of the founders of New Communities Inc. was Slater King, a cousin of civil rights' icon Martin Luther King Jr., according to Reynolds' PowerPoint presentation.

The presentation showed how Hannibal Square, a black

community started in Winter Park in the late 1800s with homes for domestic workers and Pullman porters, established its CLT in 2004. The older wood-framed homes in the neighborhood are slowly being replaced with modern expensive homes. However, since the Hannibal Square CLT was created, 26 affordable homes have been built, with 21 of them belonging to the community land trust, Reynolds said.

She showed a slide of a modern, luxurious home next to an older wood-framed home.

"This has not been photo bombed," she joked.

the feedings, but has been using its partnership with the Bread of the Mighty Food Bank in recent years to trim costs.

"One week we may feed them fried chicken, and the next week it may be spaghetti and meatballs," King said.

The church also gives away bread and other food items donated by Publix, King said.

"This is an important part of our ministry because in the Bible it says, 'I was hungry, and you fed me not,'" King said. "It is the desire of the Lord that we serve the poor among us."

Those who visit the church for the hot meals often return on Sundays to feed their spirit, King said.

"We started out using

our vans to go get the homeless from the different areas in the community where the homeless spend time, but in the past couple of years, the people have begun making their own way here," King said. "It makes us feel good knowing the people feel welcome here, not just to get a meal, but to also hear a word of encouragement from the Lord."

The meals and fellowship at the church have kept Leon Young, 61, coming back.

"This is awesome," Young said after finishing his meal Thursday. "They are the best in the world. You can't get no more better service than this here. I've known the pastor since we were raised together up in Archer, and he's the same old down-to-earth person like he's always been."

Treasure Coast and last week, a shouting crowd prompted the governor to hastily cut short an appearance in Venice, a usually reliable Republican stronghold.

Scott on Wednesday said the state has spent more than \$17 million on red tide research since 2011, including \$5 million in a partnership with Sarasota's Mote Marine Laboratory on the origins of red tide.

The governor steered another \$2.2 million to Mote this week for work aimed at easing the effect of red tide. Scott also is asking the Fish and

Wildlife Commission to seek approval from the Legislature next year for a Florida Center for Red Tide Research.

Still, the commission also took immediate steps to extend to May a current restriction on fishing for red drum and snook, lengthening it along the Southwest Coast from Naples to now include Pasco County.

The mandatory catch-and-release order, aimed at helping the hard-hit fish population rebuild, had been set to expire Oct. 12.

Charter boat captains from Gulf communities attended Wednesday's hearing, with most saying they support the restriction so that fish can replenish.

IMPORTANT INFORMATION REGARDING POSTED NOTICE SIGNS


Pursuant to Section 2.2.9(D) of the City's Land Development Regulations, posted notice signs must be placed on the land that is the subject of the application, along each street which is adjacent to or runs through the land in a manner that makes them clearly visible. Signs shall be posted at intervals of not more than 400 feet when the land subject to the application has less than 1,500 feet of road frontage. When the land subject to the application has 1,500 feet or more of road frontage, signs shall be posted at intervals of not more than 1,320 feet.

Signs shall be inspected by the City subsequent to their posting. The applicant shall be responsible for ensuring that the posted notice is maintained on the land subject to the application until the completion of the final public hearing on the application.

Signs must be removed by the applicant and returned to the City within ten days after the final decision on the application.


