

Historic Ma Barker House now has guided tours available to public

LAKE WEIR — The Bradford-Ma Barker House, site of the infamous Jan. 16, 1935, shoot-out between FBI agents and Kate “Ma” Barker and her son Fred, has opened for scheduled guided tours.

The second ever small group tour was conducted Wednesday, with Marion County South District Parks ranger Lonny Haynes taking the lead.

Deborah Carr-Hollingsworth took the tour with her husband, Larry Hollingsworth, and her father, Gary Carr.

“When we pulled up to the house I could see Ma Barker in the upstairs window. She said, ‘Get the h--- out,’ “ Carr-Hollingsworth said.

Carr-Hollingsworth is working on a book about paranormal or “haunted” sites in the region. Her family has traveled extensively due to military service, and she always tries to learn area history.

The small group tours are available through the Friends of the Bradford-Ma Barker House, Inc., a foundation set up to support efforts to keep the house in its original condition.

The front porch has been replaced, and further work is necessary, officials said. Repairs are designed to replicate the original construction.

The two-story frame house, built in 1930, was floated by barges from across Lake Weir to adjacent Carney Island Recreation and Conservation Area, a Marion County park, in 2016.

“The response to the tours has been overwhelming,” said Greg Wiley, director of operations for Marion County. He said visitors have cited history, paranormal activity and curiosity as reasons for taking the tour.

Only guided tours are allowed. The cost is \$10 per person and tours typically will last up to 90 minutes. Tour takers do not have to pay the \$7 park entry fee if they park in

the designated area.

Virginia and David Gibbons of Weirsdale have lived here at least 40 years and were interested in the history.

“Amazing,” said Virginia Gibbons as she walked about the interior of the home on Wednesday.

She said the upstairs corner room where Fred Barker died (and Ma Barker’s body was found near a closet door) gave her a “funny, strange” feeling.

She also expressed concern about preserving the many open articles in the house.

Roy Melinchak and his wife, Linda Wagner-Melinchak, also took the tour Wednesday. Linda Wagner-Melinchak said the Barker Gang was mentioned during a Route 66 tour that she and her husband had taken.

The home’s new location gives visitors a chance to see the house with many of its original furnishings and heirlooms. You can even see the walls where FBI bullets tore holes.

The Friends of the

Bradford-Ma Barker House, Inc., website states that the “Cracker”-style house has three bedrooms and measures 2,100 square feet. It was originally set on property purchased in 1892 by Carson Bradford and has always remained in the family.

The house was built in 1930 by Bradford’s son, a resident of Miami, as a weekend and summer getaway, according to the friends group’s website. The house was never rented, but in late 1934 a “generous” offer and full-season advance payment was made by a “sweet little old lady” to secure the place for her and her sons.

“The vision is for the public to enjoy maximum access to one of the most famous houses in America,” the website states. “Marion County intends to recreate the setting by opening the house to the public and providing abundant exhibits to interpret the history of the house, what happened during the shoot out and how it effectively ended a history

of organized crime and gangs in the country. We are not glorifying gangsters. We are honoring law enforcement.

“This was and is documented as the longest gun battle in FBI history. It is also basically was the death knell to the mobster and gangster movement,” the website states.

Debbie Trudeau and her husband, Ron, of Fruitland Park, and Debbie Trudeau’s daughter Kaylee Peterson and her husband, John, visiting from Virginia, took the tour.

Debbie Trudeau took a cellphone picture in a corner of the upstairs room where the Barkers died. The corner is adjacent to the closet where Ma Barker’s body was reportedly found.

She pointed to a shaded area in the center of the photo in the corner.

“I took a picture and (the dark area) was there and then took another and it was not,” Debbie Trudeau said.

“There’s definitely something there,” she said.

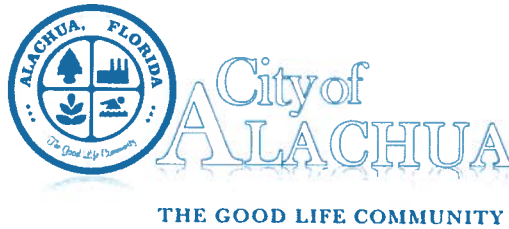
