

**RESOLUTION 19-08**

**A RESOLUTION OF THE CITY OF ALACHUA, FLORIDA; AMENDING THE FISCAL YEAR 2018-2019 BUDGET; ESTABLISHING APPROPRIATION IN THE GENERAL FUND; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Alachua Police Department has been awarded a Justice Assistance Grant for the purchase of radars and rifle mounts; and

**WHEREAS**, it is necessary to increase the Fiscal Year 2018-2019 General Fund budget in the amount of \$8,285, to reflect revenues and expenses associated with the receipt of the Justice Assistance Grant.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ALACHUA COMMISSION:**

1. The Finance and Administrative Services Director is directed to amend the Fiscal Year 2018-2019 Budget by the amount of eight thousand two hundred eighty-five (\$8,285) as reflected in the budget amendment attached hereto as Exhibit A.
2. That this resolution shall take effect immediately upon its adoption.
