

PROJECT SCOPE OF WORK PRESENTED by Rodolfo Valladares – Public Services Director

### CONTRACTOR QUESTION/ANSWER PERIOD

**QUESTION #1**: Can the Slide Presentation be posted on the City website? **ANSWER**: Yes, the slide presentation will be posted on the City website.

**QUESTION #2**: Clarify the amount of gravel in the sand area.

ANSWER: In accordance with City of Alachua Design and Construction Requirements (2017), Section 3.3.

Paragraph B.4.c. Bedding

1) Provide imported granular fill bedding material.

Clarification: imported granular fill shall consist of sand or silty sand classified as SP or SM in accordance with USCS (ASTM D2487).

Contractor shall provide the amount of granular fill as required for the proper installation of manhole, gravity main, lateral, and pluming; as referenced in sheets addressing:

- Alternate I
- Alternate II
- Alternate III

**QUESTION #3**: How much unsuitable should be carried in the bid?

**ANSWER:** Contractor shall remove unsuitable materials as required for the proper installation for:

- Alternative I, installation of the manhole, gravity main, lateral, and plumbing.
- Alternative II, installation of the wastewater lateral.
- Alternative III, installation of the wastewater laterals.

**QUESTION #4:** Clarify the quantities on the bid form.

**ANSWER:** Estimated measurements and quantities are provided. It is the Contractor's responsibility to field measure and confirm quantities.

<u>QUESTION #5</u>: How far behind the sidewalk does the sod work need to cover disturbed areas? <u>ANSWER</u>: Contractor is responsible to sod all disturbed areas by Contractor with centipede grass.

**QUESTION #6**: Are we to include the camera inspections for wastewater testing in the bid? **ANSWER**: Contractor's responsibility to provide camera inspections.

<u>OUESTION #7</u>: If alternates are awarded, how does this affect the presented schedule? <u>ANSWER</u>: Contract time and milestones shall meet the following schedule:

- Base Bid
  - Substantial Completion 70 days from NTP
  - o Final Completion 90 days from NTP
- Alternative I
  - o 14 day extension
- Alternative II
  - o 7 day extension
- Alternative III
  - o 7 day extension

**QUESTION #8**: Can roads be closed down to perform the sewer work?

**ANSWER**: Yes, Contractor is responsible to perform road closure and notify as required in accordance with *City of Alachua Design and Construction Requirements* (2017), Section 3.13.

Clarification: Contractor shall notify in writing the Public Services Project Manager no less than 7 days prior to such closures or whenever roads are impassable. Contractor shall immediately notify the Public Services Project Manager of any vehicular or pedestrian safety or efficiency problems incurred as a result of the Work.

Public Services Project Manager will coordinate and notify as needed with Alachua Police Department.

**QUESTION #9:** Can the force main be turned off for bypass pumping?

**ANSWER**: No, the force main may not be turned off for bypass. City must provide continuous utility service.

**QUESTION #10**: Does Contractor reconnect sewer to residents?

**ANSWER**: If alternative is selected by the City, Contractor will be responsible for reconnecting sewer to residents.

**QUESTION #11**: When installing sewer lines on residential property what is the Contractor responsible for replacing on the resident's property?

**ANSWER**: Contractor will be responsible for replacing landscaping, irrigation and putting holes in the bottom of septic tanks. Contractor will be required to mitigate septic tanks contents.

**QUESTION #12**: How far is the sidewalk from pavement?

**ANSWER**: Two feet minimal; Contractor to field coordinate as needed.

**QUESTION #13:** What is the shoulder treatment requirement?

**ANSWER**: In accordance with Section 1.3 Schedule of Street Segments 1-27 – Work Scope A-G, Shoulder Treatment/Disturbed Areas:

- 1. Remove overburden and construct 3-ft shoulder treatment adjacent to roadways with inverted and crown road profiles.
- 2. Sod all disturbed areas with centipede grass.
- 3. Remove and properly dispose of excess material from project site.

**QUESTION #14:** Are line locates available for bidding purposes?

**ANSWER**: Underground Utilities shall be notified and utility locates performed (call 811) prior to beginning construction. The utmost caution shall be taken in all operations to avoid damage to existing obstructions (for example, pipes, cables, conduit, utility poles, structures, etc.) whether or not shown on the Drawings.

Contractor is responsible to notify underground utilities, notification center at 1-800-432-4770 or 811 at least 72 hours prior to start of work for Design Ticket Request indicating areas to be located.

**QUESTION #15**: Who is responsible for the removal of the tree located at corner of NW 158<sup>th</sup> Avenue and NW 141<sup>st</sup> Street?

**ANSWER**: If Alternative I is selected by the City, City will remove tree located at the corner.

**QUESTION #16**: What is the estimated cost for this project?

ANSWER: Budgeted amount is \$694,000.00.

## **CLARIFICATIONS:**

Roadway work includes mill existing asphalt, clean and repave the roadway matching existing roadway measurements.

To clarify, as shown on drawings sheet *Alternate I*, the installation of new manhole is to be placed in middle of roadway.

The installation of the new manhole should be a minimum 6-ft deep.

Depths of existing manholes are marked on the drawings.

The City of Alachua will test asphalt thickness.

Quote for Alternate I should be according to design plans.

The tree located on NW 154th Avenue and NW 141st Street will removed by the City of Alachua.
