hardware supplier (literally nuts and bolts and the like), supplying independent hardware stores over a multi-county area.

To adapt, Stringfellow expanded into larger building materials, like roofing supplies and lumber. With the advent of hardware chains, Stringfellow became more of a local distributor.

In what was one of the city's most memorable fires, the operation burned in the mid-1980s, and Stringfellow stepped back and his grown children then took on responsibility for rebuilding and running the business.

While Stringfellow enjoyed work, he was more interested in customers and employees than becoming a corporate titan, his son said.

"I think sometimes a lot of folks think that people

who excel in business are all about personal gain. And he excelled in business, but he was all about other people," Stringfellow Jr. said. "He was never about personal gain. He never had any love for material things. He was about the human condition and about those who had less and those who were in need."

Among his many interests, Stringfellow most frequently found himself involved in health-related issues. He chaired the advisory board for the CHOICES program created by the county in the mid-2000s, a voter-approved, quarter-cent sales tax meant to help the county's poorest residents get health care without clogging hospital emergency rooms — a precursor to today's health care debates.

He helped get FluMist to schoolchildren. He chaired the board of the Partnership for Strong Families and lobbied Tallahassee for better child

welfare funding.

Jody Davis, a CPA-turned-divorce mediator who became a friend to Stringfellow years ago when they frequently served on civic committees and boards together, said he always felt confident if Stringfellow was behind a cause.

"You could just feel good, if he was involved in something, you'd know it was for the right reason. Not for his ego, it's to help," he said.

Besides his wife and son, Stringfellow is survived by sons Richard Stringfellow and Doug Stringfellow, daughter Martha Murphree Stringfellow York, and seven grandchildren.

A funeral service is set for 10 a.m. Saturday at Holy Trinity Episcopal Church, 100 NE First St. in downtown Gainesville. The family asks that instead of flowers, memorial donations be made to Partnership for Strong Families or Haven Hospice.

'Sanctuary city' fight goes down to wire

TALLAHASSEE — For the second time this legislative session, the House on Wednesday sent a strict "sanctuary city" bill to the Senate, where Senate President Bill Galvano has already said he plans to make changes and bounce the issue back to the House.

"We are the Senate, and we've made our own adjustments and we will make adjustments again,"

Galvano told reporters on Wednesday.

With pressure coming from Gov. Ron DeSantis, who promised supporters he would ban so-called sanctuary cities, Republican leaders in both chambers are scrambling to pass a plan before the session ends this week.

It remains unclear whether DeSantis would prefer the House or Senate version of the bill.

Proposed sanctions remain the key difference

between the chambers. The House wants stricter penalties than the Senate. Those include punishing local and state officials who do not fully cooperate with federal immigration authorities with fines, suspensions and removal from office.

If the Senate waters down the enforcement portion of the bill and sends it back to the House, Speaker Jose Oliva, R-Miami Lakes, said he would be willing to look at the Senate proposal.

aggravated battery. She was released in 2014. Jones earned her GED while in prison and is taking courses online with Colorado Technical University as she pursues a bachelor's degree in business administration.

"If I had someone to talk to about all of the pain that I had been keeping inside of me for so many years, I would have never gone to prison," Jones

said.

Williamson said he is working with the event's organizers because he wants people to know there is a peaceful way to live.

"If we get people to change their minds, they will change their lives," he said. "If there is a problem between me and you, let's find a peaceful solution."

Jones and Williamson said nefarious activity near "The Slab" has ceased since the shooting death of Davis in March, and they both said it is important to do something to keep troublemakers away.

"There must be constant positive activities up there to let people know there is a better way," Williamson said.

Jones said plans are to have similar events one Saturday every month and she said the one in June also will include representatives from community resources to help people learn about programs they can take advantage of to live better lives.

"You have to get people's minds and hearts right before you start talking about controlling gun violence," she said. "If I can change, a change can come."

parkway in the past.

Billionaire Republican donor Thomas Peterffy, a Palm Beach resident and member of President Trump's Mar-a-Lago club, also owns a half-million acres in North Florida, some of which could be eyed for development with the road projects.

Rep. Margaret Good, D-Sarasota, said, "These toll road corridors will use almost 5.4 million acres of farm and rural lands and if you think about the wetlands we are going to destroy by building roads ... isn't it worth it to do the study before making the determination?"

Lawmakers also defeated an effort Wednesday that would have sent the task force studies back to the Legislature to determine whether to go ahead with any of the road projects.

The Tampa-area Suncoast Parkway, which now stretches less than 60 miles from Hillsborough County to Citrus County, would extend another 150 miles to the Georgia line, under the plan.

It would serve as a hurricane evacuation route, but also bring development to central and north Florida counties. Another new road proposed would stretch as much as 150 miles, from the ranch and citrus groves of Polk County to Collier County and the Gulf Coast, south of Fort Myers.

Galvano's final ribbon of road is a proposed 30-mile extension of Florida's Turnpike from where it connects to Interstate 75 near Wildwood to the expanding Suncoast Parkway, a roadway expected to ease travel on the traffic-choked interstate.

Still, a Florida Department of Transportation Interstate 75 Relief Task Force recommended in 2016 that rather than new roads, a better approach was expanding the vehicle capacity of the interstate and connecting highways.

Trumbull, however, pointed to the highway system enhanced in the 1950s that led to Florida's development. The road projects envisioned are the state's biggest road construction effort since Florida's Turnpike was begun in the middle of that decade.

"Can you imagine today driving through the middle of our state without the Florida Turnpike system?" Trumbull asked House members.

Major agribusinesses including Alico Inc., A. Duda & Sons, Lykes Brothers and phosphate giant Mosaic have supported the Polk-to-Collier

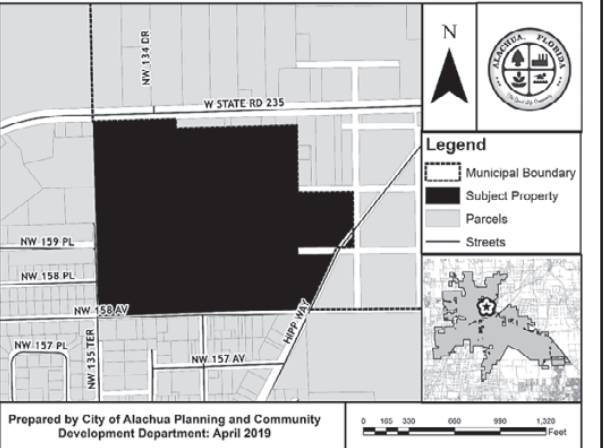
Still, it would likely take a lot for DeSantis to veto Galvano's top issue.

Opponents, though, said the Legislature's action should anger taxpayers.

"This is why Floridians are so cynical about government," said Jonathan Webber, deputy director of Florida Conservation Voters. "Legislative leaders let billionaire landowners and high-powered lobbying groups treat taxpayer dollars like their personal piggy bank."

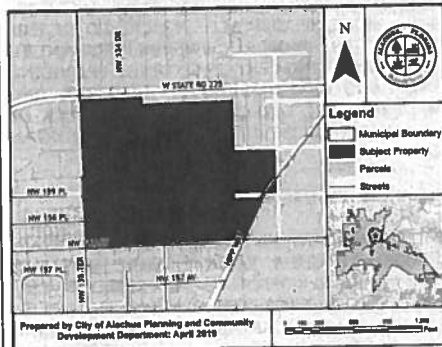

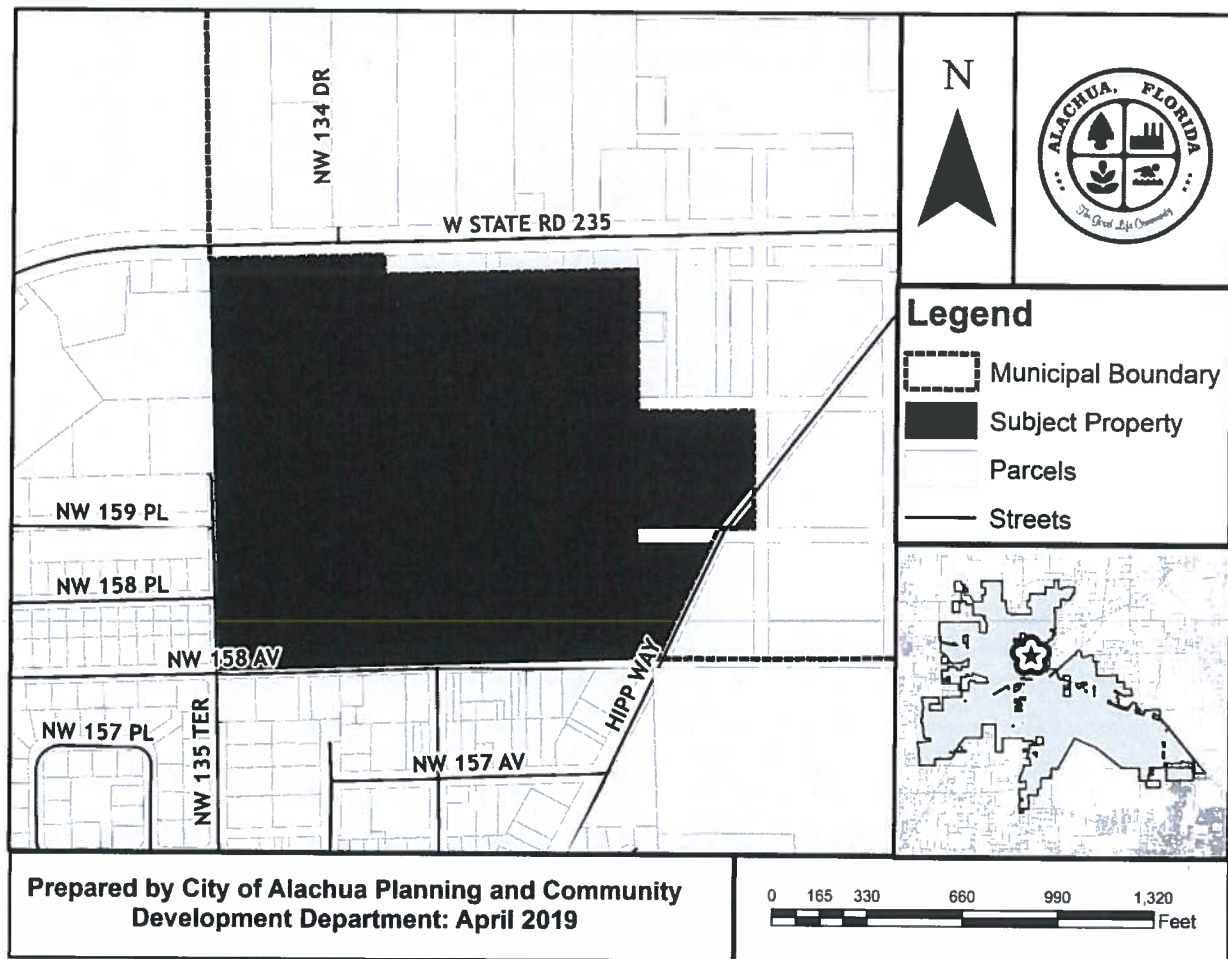
