Ordinance 19-23, Second Reading; Large Scale Comprehensive Plan Amendment: A request by Clay Sweger, AICP, LEED-AP, of eda engineers-surveyors-planners, inc., applicant and agent for The Laser Investment Group, LLC., property owner, to amend the Future Land Use Map (FLUM) Designation from Commercial, Industrial, and Rural Employment Center (Alachua County) to Corporate Park on a ±82.40 acre subject property. Consisting of Tax Parcel Numbers 05962-002-000, 05855-005-000 and a portion of 05855-004-000 (Legislative Hearing).

Ordinance 19-25, Second Reading: Land Development Regulations Text Amendment: A request by Christopher Gmuer, P.E., of Gmuer Engineering, Inc. to amend the City of Alachua Land Development Regulations (LDRs) Section 5.1.2, Table 5.1-2, Related to the Dimensional Standards within Residential Zoning Districts; Section 7.3.1 (B)(1), relating to required standard street improvements for subdivisions; Section 7.3.1 (B)(2), relating to design requirements for streets utilizing transitional swales; Section 10.2, creating a definition for "transitional swale" (Legislative Hearing)

Planner Hall introduced the item and provided the staff report.
