#### IV. PUBLIC HEARINGS AND ORDINANCES

(Presentations, other than the applicant, please limit to **3 Minutes**)

A. Briarwood Preliminary Plat: A request by Craig Rouhier, of Troon Development, LLC agent for Golden Pond Farms, Inc., property owner, for consideration of the Preliminary Plat for the Briarwood Subdivision, which proposes the subdivision of a ±74.17 acre subject property into a total of 229 lots, with associated common areas and right-of-way. Tax Parcel Numbers 03044-011-001, 03044-011-002, 03044-011-003, and 03044-010-003 (Quasi-Judicial Hearing).

Having been sworn in, Planner Adam Hall introduced the item and provided the staff report.

Having been sworn in, Dave Glunt of Spruce Creek Civil Engineering provided an additional presentation.

Mayor Coerper asked the commissioners for questions or comments.

Mayor Coerper asked about road improvements.

Mr. Glunt stated he would bring concerns to the County during the application process.

City Attorney Marian Rush asked Mr. Glunt if he agreed with the six conditions to the project.

Mr. Glunt stated he agreed with five of the conditions. Regarding the sixth condition, he stated the applicant would like to add PVC as an allowable material for fencing.

City Attorney Rush stated PVC may be added, but not to remove the material of wood, as staff must review the change.

City Manager Boukari provided information regarding the zoning applicable to this property. He addressed concerns presented at the Planning and Zoning meeting and stated that accommodations are being made by the applicant of his own free will.

City Attorney Rush addressed the concerns regarding water runoff and the sizes of the lots along the back of the property.

Mayor Coerper pointed out the neighborhood meetings were started so that the neighboring developments could voice their concerns.

Vice Mayor Miller asked about the Alachua West Infrastructure Improvements project in relation to this project and what a PVC fence looks like.

Planner Hall provided the information.

City Manager Boukari provided additional information.

#### Vice Mayor Miller moved based upon the competent substantial evidence presented at this

hearing, the presentation before this Commission, and Staff's recommendation, this Board finds the application to be consistent with the City of Alachua Comprehensive Plan and in compliance with the Land Development Regulations and approves the Preliminary Plat for the Briarwood subdivision, subject to the six (6) conditions provided in the revised Exhibit "A" and on Page 19 of the Staff Report, with the amendment to include PVC as an optional building material for the fence; seconded by Commissioner Hardacre.

Mayor Coerper opened the floor for comments.

City Manager Boukari read a letter into record from Frances Cherry.

Vice Mayor Miller asked about the height of the fence.

Commissioner Hardacre asked if Mr. Glunt could commit to an 8' fence.

Mr. Glunt stated the landscaping could more than cover this desire, and would not commit to an 8' fence.

Commissioner Wilford asked about the sinksholes and the gopher tortoises mentioned, as well as second entrance.

Planner Hall provided the information.

City Manger Boukari added to the comments.

City Attorney Rush informed the citizens of the Joint City/County meeting which occurs yearly, where they could come and voice their concerns regarding CR235A.

B. Ordinance 20-02; First Reading: Site-Specific Amendment to the Official Zoning Atlas - A request by Clay Sweger, AICP, LEED AP, of EDA Engineers - Surveyors - Planners, Inc., applicant and agent for Property 441, LLC, property owner, to amend the Official Zoning Atlas from Agricultural ("A") (Alachua County) to Community Commercial ("CC") on a ±8.5 acre subject property. Consisting of a portion of Tax Parcel No. 05899-001-000 (Quasi-Judicial Hearing).

#### City Attorney Marian Rush read Ordinance 20-02 by title only.

Having been sworn in, Principal Planner Justin Tabor introduced the item and provided the staff report.

Mayor Coerper asked the commissioners for questions or comments.

Mayor Coerper and Commissioner Wilford asked for clarification regarding the map.

Principal Planner Tabor provided the information.

Clay Sweger of EDA provided more information.

Commissioner Hardacre moved based upon the competent substantial evidence presented at this hearing, the presentation before this Commission, and Staff's recommendation, this Commission finds the application for a Site-Specific Amendment to the Official Zoning Atlas for Property 441, LLC to be consistent with the City of Alachua Comprehensive Plan and in compliance with the Land Development Regulations and approves Ordinance 20-02 on first reading and schedules second and final reading for November 18, 2019; seconded by Vice Mayor Miller.

Mayor Coerper opened the floor for comments.

There were no comments.

#### <u>Commissioner Wilford moved to authorize Mayor to execute agreement between Alachua</u> <u>County Sheriff and City of Alachua for Alachua County PSAP; seconded by Vice Mayor</u> <u>Miller.</u>

Mayor Coerper opened the floor for comments.

There were no comments.

#### Passed 4-0 by roll call.

B. Legacy Park Multipurpose Field Lighting Authorization

Communications & Executive Project Manager Mike DaRoza introduced the item and made recommendations.

Mayor Coerper asked the commissioners for questions or comments.

Commissioner Hardacre asked about the lighting interfering with the amphitheater.

Communications & Executive Project Manager DaRoza and City Manager Boukari provided information.

<u>Commissioner Hardacre moved to authorize the City Manager to enter into a contract with</u> <u>Musco Sports Lighting, LLC for lighting at the Legacy Park Multipurpose Fields in an</u> <u>amount not to exceed \$170,000; seconded by Commissioner Wilford.</u>

Mayor Coerper opened the floor for comments.

There were no comments.

Commissioner Wilford asked about the fountain at Legacy Park.

City Manager Boukari stated it was being repaired.

City Attorney Rush stated she attended the ribbon cutting for the amphitheater and walked the facilities, and was impressed.
