Bronson man charged in parking lot robbery

Duthill planned the armed robbery with Patrick James Abbott, 20, and Austin Reed Fletcher, 20,

Fletcher held up a handgun during the robbery, Duthill snatched the drugs and some school books from Reed's vehicle and Abbott drove the getaway vehicle, the complaint said.

scene, Reed, a University of Florida student from Hawthorne, fired at least 15 gunshots at the men, striking them all as they tried to run away, the complaint said. Gunshots also struck the getaway vehicle and Walmart building.

Police arrested and later released Reed from the Alachua County Jail in September. He faces three charges of attempted murder and marijuana possession.

Fletcher was arrested in September and remains in the Alachua County Jail on an armed robbery charge.

Abbott, who is charged with armed robbery. was arrested in October and released from jail in December.

Florida Highway Patrol arrested Duthill in September on charges of fleeing the scene of a hitand-run crash involving property damage, operating a vehicle without a valid license and probation violation for a 2018 burglary, said Lt. Scott Tummond with the Levy County Sheriff's Office.

He remained in the Levy County Jail from Sept. 29 through Tuesday, when he was transferred to the Alachua County Jail on a charge of armed robbery, where bail is set at \$250,000.

Waldo man dies in motorcycle crash

A Waldo man died of his injuries following a crash early Wednesday morning in which his motorcycle entered a ditch, hit a culvert and became airborne before landing in another ditch outside a bar.

Daniel Joe Russell, 34, was driving south on U.S. Highway 301 in Waldo at about 3:30 a.m. when his vehicle left the roadway for unknown reasons and traveled into a ditch, according to a Florida Highway Patrol press release.

The motorcycle then hit the culvert, causing it to become airborne, the release said, before it came to a final rest in a ditch outside Mugshots Bar. Russell died at the scene.

He was not wearing a helmet at the time of the incident, the release said.

university consolidation push, speakers at the committee hearing also criticized another aspect of the bill that would change the eligibility requirements for a grant program used by students attending private colleges.

"We received many, many phone calls in opposition to this bill," said Rep. Susan Valdes, a Tampa Democrat.

Valdes said New College and Florida Polytechnic should have been consulted about the legislation, something Fine said did not

Supporters of keeping New College and Florida Polytechnic independent said that the schools may have higher costs per degree, but said it's worth it because they enhance the overall university system by providing education options that either are unique, in the case of New College, or especially valuable, in the case of Florida Polytechnic.

New College is the state's public liberal arts honors college. It does not issue grades and has an enrollment of just 724 students. It's cost per degree is higher because of its small size, which ensures that administrative expenses are a greater percentage of the overall budget than at larger schools with more economies of scale.

Florida Polytechnic is the state's newest university. It was founded in 2012 and focuses exclusively on science, technology, engineering and math (STEM) degrees, which tend to cost more to produce.

Supporters of both schools asked lawmakers not to take away their independence.

relied on in-depth evaluations and rigorous course work instead of grades as the public honors college of Florida," said Flannery French, who received a bachelor's degree in anthropology from New College and is applying to master's and doctoral programs.

"I believe remaining independent will let New College retain its uniqueness," French added.

A mother of two New College students told the committee that the education provided by

the Sarasota school is "outstanding."

"The honors college setting is one of a kind in Florida," said the woman, who noted that her son quickly found a job after graduation.

Florida Polytechnic President Randy Avent said the school's degrees may come with a higher price tag but also tend to result in higher-paying jobs. Avent cited a report that

found engineering degrees on average cost more than twice as much to produce than other degrees, but noted his students also have a median starting wage of \$54,800.

"The bottom line is that Florida Poly is not expensive because it's small, it's expensive because it's 100% STEM," Avent said.

New College President Donal O'Shea also has criticized the legislation. So have a number of lawmakers in the communities where New College and Florida Polytechnic are located.

Most of the Education Committee members did not express big concerns about the consolidation effort, though. The most vocal criticism came from state Rep. Amber Mariano, a Pasco County Republican.

"Eliminating two of our 12 state universities seems rushed," Mariano said.

Much of the discussion at the hearing instead focused on proposed changes to Florida's Effective Access to Student Education (EASE) grant program, which helps students attend private nonprofit colleges.

Fine's bill proposes to limit the \$2,841 EASE scholarship to students who are considered financially needy. The means-testing proposal brought extensive criticism from private college administrators and students.

The presidents of Keiser "Ilove that New College University campuses in Sarasota and Jacksonville both testified against the bill, as did representatives for the University of Miami and Flagler College.

> "This grant is imperative, it stops our students from having to take out loans for their education, or more loans for their education," said Flagler College's financial aid coordinator.

Fine said taking away scholarships and closing universities might not be popular, but he argued that it is good fiscal policy for the state.

"I was asked to do this job

because I have no allegiance or lovalty to anything but what is right," Fine said, adding: "See, there's no one who's going to stand up here and say, hey it's great to take away people's scholarships, or it's great to close a university; that doesn't mean it's not the right thing."

Fine noted that New College and Florida Polytechnic likely will continue in some form as satellite campuses, although what they would look like under the umbrellas of FSU and UF was not discussed.

"These campuses don't necessarily go away but there will be efficiencies," Fine said.

Representatives of FSU and UF did not speak Wednesday, but Fine said they were consulted about the bill.

"University of Florida and Florida State is wellversed on the plan," Fine

But FSU President John Thrasher, speaking after FSU Day at the Capitol, said "I didn't know about it until it was filed."

"I just saw that yesterday," Thrasher said. "I haven't had a chance to look at it. That's in the wisdom of the Legislature, whatever they decide. We're here to carry out what they ask us to do, and

we'll see what happens." Asked if he had any initial thoughts on the proposal, the former House speaker and senator said: "I really don't. I think it just started. I'm not sure they have a lot of thoughts on it yet. We'll watch it closely."

Fine's bill thus far does not have companion legislation in the Senate. but Senate President Bill Galvano – whose district includes New College said he is willing to consider the consolidation proposal.

"I think it's worthy having the discussion and I'm open to that dialogue with the speaker and the Florida House," Galvano said Wednesday.

"You know, both of those universities started out as the University of South Florida," Galvano added, referring to past iterations of New College and Florida Polytechnic as USF satellite campuses. "These type of discussions are healthy from time to time."



dislodge the blockage. He then helped the student to the nurse's station where the student received further treatment and evaluation.


Because of Taylor's quick action at such a critical time, Police Chief Antoine Sheppard awarded him the Life Saving Award and read the plaque to the audience.





IMPORTANT INFORMATION REGARDING POSTED NOTICE SIGNS

Pursuant to Section 2.2.9(D) of the City's Land Development Regulations, posted notice signs must be placed on the land that is the subject of the application, along each street which is adjacent to or runs through the land in a manner that makes them clearly visible. Signs shall be posted at intervals of not more than 400 feet when the land subject to the application has less than 1,500 feet of road frontage. When the land subject to the application has 1,500 feet or more of road frontage, signs shall be posted at intervals of not more than 1,320 feet.


