





PROCLAMATION

WHEREAS, Alachua's future prosperity depends on nurturing the healthy development of the children currently residing in Alachua; and

WHEREAS, the abuse and neglect of children can cause severe, costly and lifelong problem, including physical and mental health problems, school failure and criminal behavior, which affect all of society; and

WHEREAS, research shows that parents and caregivers who have social networks and know how to seek help in times of trouble are more resilient and better able to provide safe environments and nurturing experiences for their children; and

WHEREAS, individuals, businesses, schools, and faith-based and community organizations must make children a top priority and take action to support the physical, social, emotional and educational development and competency of all children; and

WHEREAS, children deserve the opportunity to grow and thrive in healthful environments, free from threats of violence and harm; and

WHEREAS, during the month of April, public and private-sector agencies, child care professionals, child advocates, and residents will be increasing the public's awareness of child abuse and neglect prevention



MEETING DATE: 3/25/2024 **SUBJECT:** Public Safety Radio System User Agreement **PREPARED BY:** Jesse J. Sandusky - Chief of Police

RECOMMENDED ACTION:

Recommended action is to accept and have the Mayor and City Attorney execute the new user agreement.

Summary

Historically, public safety radio services county-wide have been provided by GRUCom, the communications arm of Gainesville Regional Utilities (GRU). This includes 10 partner agencies, including the Alachua Police Department. All local law enforcement agencies, fire rescue agencies, and some local municipal and federal agencies utilize the trunked radio system (TRS) that until recently, has been wholly owned and operated by GRUCom.

Alachua County Board of County Commissioners has recently purchased the radio system previously owned by GRUCom. This has resulted in a more equitable share amongst all system users. After the purchase, all partner agencies, including the Alachua Police Department, received new user agreements. Under the new agreement, the City of Alachua will pay Alachua County a total \$84,084.00 annually for a period of 5 years. This annual payment will be made in 12 monthly installments of \$7,007.00. After 5 years, the agreement will be renegotiated.

PUBLIC SAFETY RADIO SYSTEM USER AGREEMENT

This agreement is between Alachua County, a political subdivision of the State of Florida (County) and the City of Alachua, a municipal corporation of the State of Florida (User), collectively referred to as Parties.

WHEREAS, Alachua County has purchased the Public Safety Radio System (PSRS), also known as the Trunked Radio System, previously owned by the City of Gainesville; and,

WHEREAS, it is in the public interest that public agencies have access to the PSRS for purposes of interoperability, and communication with the Combined Communications Center which provides county-wide dispatch services and allows for the efficient operation of local governments which use the PSRS; and

WHEREAS, the User operates a public safety agency that qualifies to use the frequencies allocated to the PSRS.

THEREFORE, the Parties agree as follows:

- 1.) This agreement shall be effective as of 12:00 a.m. on January 1, 2024 and shall renew annually on October 1, unless terminated by the parties.
- 2.) The Parties agree and acknowledge that the PSRS is and will remain under the sole control of County, including as required by the Federal Communications Commission (FCC) regulations. County hereby permits User to utilize the components of the PSRS required for interoperable communication, including the frequencies occupied by the PSRS and the talk groups assigned to User, subject to reasonable limitations on the foregoing as may be imposed by the County. User shall ensure that its use of the of the PSRS and the use of same by its employees, agents, vendors, and subcontractors shall strictly comply with the terms of this Agreement, any operating procedures or protocols as maybe established by County from time to time, and all applicable laws and regulations, including FCC regulations.
- 3.) User agrees to abide by all applicable restrictions and limitations on the use of the PSRS as defined by the County or otherwise required by FCC regulations.
- 4.) All of User's equipment must comply with County's technical specifications and requirements for such equipment utilizing the PSRS. County shall provide User with these technical specifications and requirements upon request and shall provide written notice to User of any material changes (including changes that would require replacement or upgrade of existing units) at least ninety (90) days in advance of any such material change.

- 5.) User is solely responsible for the purchase of Subscriber Units (Radios), and any such purchase (including any required upgrade or reprogramming) will be at the expense of the User. Subscriber Units must be procured by User and must be approved in writing in advance by the County; in all instances, User must obtain County written approval of the Subscriber Units prior to utilization on the PSRS. The user is also solely responsible for the costs of programming the Subscriber Units. Programming and reprogramming of Subscriber Units may only be performed by the County, unless otherwise expressly approved in advance in writing by the County, and such approval shall not be unreasonably withheld.
- 6.) For all User's Subscriber Units, User shall meet or exceed the minimum maintenance standards as recommended by the Unit owner's manual. County may offer (but is not required to) and the User may utilize (but is not required to) maintenance services by County for Subscriber Unit maintenance at County's then-current rates. In all events, the User shall utilize only repair facilities or persons expressly approved in writing by County to maintain or repair any Subscriber Unit, and such approval shall not be unreasonably withheld.
- 7.) User shall have access to system reports upon request.
- 8.) User will pay to County \$7,007.00 in 12 equal monthly installments totaling \$84,084 annually for a period of 5 years. At the end of 5 years the payment for services under this agreement will be renegotiated to include a method for the calculation of user fees going forward. It is the intent of the parties that services will continue to be provided.
- 9.) Notices. In order for a notice to a party to be effective under this Agreement, notice must be sent via U.S. first-class mail, with a contemporaneous copy via e-mail, to the addresses listed below and shall be effective upon mailing. The addresses for notice shall remain as set forth herein unless and until changed by providing notice of such change.

- 10.) The Parties agree that an electronic version of this Agreement shall have the same legal effect and enforceability as a paper version. The Parties further agree that this Agreement, regardless of whether in electronic or paper form, may be executed by use of electronic signatures. Electronic signatures shall have the same legal effect and enforceability as manually written signatures. Delivery of this Agreement or any other document contemplated hereby bearing a manually written or electronic signature, by electronic mail in "portable document format" (".pdf") form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, will have the same effect as physical delivery of the paper document bearing an original or electronic signature.
- 11.)Sovereign Immunity. Nothing in this Agreement is intended to serve as a waiver of sovereign immunity by the County or the User to the extent sovereign immunity may be applicable.
- 12.) In the event that the purchase by the County of the Public Safety Radio System be held invalid and the PSRS be returned to the ownership and operation of the City of Gainesville, this agreement will cease to have any effect as of the turnover. All amounts due under this agreement will be payable based upon a pro-rata calculation of the time that the County operated the PSRS. The County shall not be held responsible for any costs or damages resulting from a reversion of the ownership of the PSRS under this paragraph.
